### A new cultural center announced

MONTREAL, Quebec - Mayor Michael Applebaum of the CDN-NDG Borough, was the guest speaker during the FAMAS assembly that was called to ratify the amended constitution and bylaws on Saturday, February 19 at St. Malachy's Church on Clanranald Avenue. He announced the good news about a cultural community center soon to be renovated on Barclay and Victoria which is located in the heart of the Filipino-Canadian community neighborhood. He said that he was making the announcement to the members of FAMAS who were the first ones to learn about it. According to the Mayor, the details would be finalized within the next seven months.

After the Mayor's speech, Au Osdon proceeded with the assembly by giving up the chair to Ramon Vicente so that she could participate in the discussions

Immediately before anything could be discussed, Fred Magallanes raised the question of a quorum stipulated in the constitution, and strongly suggested to set aside the ratification until the August elections. A heated exchange of opinions ensued among all those who wanted to reject Magallanes' argument and others who agreed with him. interpretations of the Practical Robert's Rules were made by Au Osdon, Melle Lugod, Andrea Neufeld and Budz Sarmiento. The gist of their arguments in favor of considering the acual attendance as a quorum was due to the fact that it had never been possible to assemble 1,200 people in one place, even for any other reason like a social dance. But Magallanes adamantly insisted on his point and demanded that Vicente should rule Vicente then asked the assembly to make a decision by standing up to vote yes to go ahead with the ratification. The majority stood up and the motion to continue

PARIS – Women took to the streets worldwide Tuesday, March 8 to mark the 100th International Women's Day, with protests against honour killings, their objectification in Italy and killings in Ivory Coast.

Drawing inspiration from the boardrooms of Finland and the toppling of autocratic regimes in Tunisia and Egypt, demonstrators staked their claim for equality, education and a better life.

### Guest Editorial

### Good for the team, but not too good for the truth

The Encarta dictionary defines objectivity as the ability to perceive or something without being describe influenced by personal emotions or prejudices. From a journalist's prejudices. perspective, objectivity means distancing yourself from friends, relatives, and the rest of the community so that you see all events and all viewpoints as equally remote and important or unimportant, as the case may be. For most journalists, to be objective is much easier said than practiced.

The true nucleus of journalism is objectivity — seeing the truth in its entirety and being fair about it. There is some dispute about whether objectivity really exists in journalism. How do journalists know the truth? It's the thing most journalists always fall short of, but the thing they always make their utmost to obtain. Opinion journalists, particularly, have to be objective just as much as standard reporters. They must be able to see reality wholly and truly. They have to face unpleasant facts just as much as anybody else.

There are a few stages of getting to objectivity. The first stage is the ability to suspend judgment while you're looking at the facts. Sometimes when we look at a set of facts we like to choose the facts that suit our thinking because it is compatible with our points of view. But if you're going to be objective - and this is not only for journalists but also for non-journalists surely the first stage is the ability to look at all the facts, whether they suit your thinking or not.

The second stage is modesty. One of the excellent models of journalism is someone we just saw at the ratification of the new FAMAS Constitution and Bylaws on February 19, 2011 - Miss Aurora Osdon, the incumbent president of the Filipino Association of Montreal and Suburbs (FAMAS). As the chairperson of the FAMAS Executive Board, Miss Osdon was supposed to be the one to preside over the special general assembly called for the ratification of said constitution and bylaws. She did preside, but only for a few minutes until she relinquished the chair to someone else. She argued that since she was a member of the ad hoc committee that drafted the document about to be ratified, she felt that she was in conflict of interest. While we disagree that there was a conflict of interest, we acknowledge that there was a combination of modesty and fairness on the part of Miss Osdon. In our opinion. Miss Osdon yielded the presiding chair because her philosophy as a leader and as a moderator is not about self-exposure. It's about self-control. It's about playing a role in the association, in particular, and in the community, in general - a socially valuable role. Community leaders have to

hold back some of themselves in order to read the pulse of the people fairly and not impose their will on them.

The same thing has to happen for journalists. We live in an age of selfexposure. But journalists have to restrain their egos so that they can see the whole truth, whether they like it or not because it's not about them; it's not about narcissism.

The third stage of objectivity is the ability to process data - to take all the facts that you've accumulated and honestly process them into a mould. This is called judgment. How do you take all the facts that are in front of you and fit them into one mould? If you hear a nasty rumor about a certain person, one part of vour brain senses how true it is. Another part of your brain senses how serious it is. Another part of your brain senses how it would affect the object of the rumor and the people around him or her. Another part of your brain knows that you're shocked in disbelief, which creates ripples across your surroundings. All these parts are disconnected and we have no idea how the human brain processes that information. But some people are really good at connecting the dots and seeing the patterns and other people are not. Surely that's the third stage of objectivity the ability to take all the data, not just the data you like, and form it into a generalized whole.

The fourth stage of objectivity is the ability to betray friends. In both Washington and Ottawa, there's loyalty to the truth and loyalty to your team. In government, loyalty to your political party is sometimes more important than lovalty to the truth. If you're a U.S. Senator or a Member of Parliament, you can't tell the truth all the time. If you work for an administration, you can't tell the truth all the time because government is a team sport. If you are a member of the executive board of a community organization, such as FAMAS, you can't tell the truth all the time because you will be accused of not being a team player. The only way you can get something done is collectively - as a group. It takes a majority to pass a piece of legislation. It takes an administration working together to promulgate a policy. It takes a cohesive board of directors to realize a goal. That's all right. Politicians and community leaders betray the truth all the time in favor of loyalty to a higher good for them. But for journalists and for most citizens, loyalty to the truth should supplant loyalty to the team. Frankly, though, it rarely happens. For example, when this writer considered publishing a dissenting opinion about Miss Osdon's decision to yield the presiding chair to somebody else, he was deluged with equally unfavorable remarks from her friends and supporters that compelled him

The fifth stage of objectivity is the ability to ignore stereotypes. This is the oldest rule of journalism. Walter Lipmann, who was twice awarded the Pulitzer Prize, once noted that most journalism is about the confirmation of stereotypes - preexisting generalizations we all have in our heads. The ability to ignore these stereotypes is crucial to objectivity.

The last one, the sixth stage, is a willingness to be a little dull. It's easy to write a lambasting, vitriolic attack on someone. But usually, unless that person is the notorious editor-in-chief of another local newspaper and who has the propensity for lying, that's not fair.

While we always strive to be objective, we realize that our ability to obtain the truth is compromised by many factors, most particularly in the level of community journalism. Some of those factors are psychological, some are economic, some are political and some are personal.

parliament. Women are treated like objects. I'm ashamed to have a prime minister like Berlusconi", protester Irene D'Onfronio, 62.

In Washington, Secretary of State Hillary Clinton said the United States will push for women to be included in the transition democracy in Arab countries.

"In the coming months and years, the women in Egypt and Tunisia and other nations have just as much right as the men to remake their governments to make them responsive, accountable, transparent", Clinton said at an awards ceremony.

But in Cairo hundreds of Egyptian women rallying for their rights on Women's Day were confronted by men who shouted at them to return home, according to media reports.

In Turkey, women chanted "Don't Turn Our Wedding Dresses into Shrouds", as they marched against socalled honour killings, when a male family member kills a woman deemed to have brought shame on the family.

Hundreds of women demonstrated in Ivory Coast. meanwhile, to condemn the shooting of seven women at a rally last week demanding that strongman Laurent Gbagbo quit the presidency after losing elections.

Mostly dressed in white and wearing red headbands, they marched to "pay homage to the women killed", an organiser said. "We are not going to stop demonstrating until Laurent Gbagbo leaves".

Brazilian President Dilma Rousseff, the first woman to lead the giant South American country, said eradicating poverty is her top goal, and can be achieved through policies designed to help women and children.

Revelers in Rio de Janeiro paid tribute to Women's Day as only they can -- with an irreverent celebration near a Carmelite convent, a tradition during Carnival.

Meanwhile in Guatemala. where a culture of impunity saw nearly 700 women killed last year alone, the head of a commission on "femicide" called for a specific statute on the killing of women.

In Peru, at least 123 women were killed in 2010 by their partners or former partners, authorities said.

A group of women in Venezuela participated in an event in Caracas honoring the heroines of the country's independence.

Palestinian women took to the streets of Gaza to call for an end to the Israeli occupation.

In the West Bank town of Beit Ummar, dozens of women blocked a major road for half an hour to protest Israeli roadblocks.

"Part of the women's rights issue is the harm caused by the Israeli occupation", said activist Fadwa Khader. "Can you imagine women being woken up and kicked out of their homes in the early morning so their homes can be demolished to make way for settlements?"

The European Union hailed women's "crucial role in bringing about change in northern Africa".

"Amidst violence, women have joined the struggle for change", said European Commission Vice Presidents Catherine Ashton and Viviane Reding in a joint statement. "Women must be at the heart of the discussions over the future order".

Whether in T-shirts and jeans or robes and veils, tens of thousands of women have recently made their voices heard on the streets, from Tunis to Cairo, from Manama to Sanaa, to demand reform in a region long ruled by autocracies.

"The situation of women in Afghanistan is improving in spite of a lot of challenges", said Maria Bashir, an investigative prosecutor in Afghanistan who accepted an award from the US State Department for showing courage in the face of Taliban threats.

Bashir said women now hold public office and girls have access to education in her country. But she added that "Afghan women feel looming alarmed" about the withdrawal of NATO forces.

Angel Gurria, head of the Organization Economic for Cooperation and Development, called gender equality "a moral imperative as well as an economic necessity".

Visiting Finland -- a country whose president, prime minister and opposition leader are all women -- US Vice President Joe Biden echoed the

"The single most significant thing we can do in the 21st century to improve the prospect of peace and security is to educate more women", he said.

His boss President Barack Obama celebrated women's "extraordinary gains" over the past century as he called for greater gender equality.

Greece, where economic crisis has thrown disproportionately more women out of work, feminists staged a flash mob dubbed "Three Minutes Without Women" in a central square of Athens.

In Norway -- the first country in the world to force large companies to gender balance their boardrooms -officials said the quotas should be extended to more companies.

A Moroccan human rights group called for the kingdom to inscribe gender equality in the constitution. Laws protecting girls from forced marriages are poorly enforced.

The minimum age of marriage for women was raised to 18 from 15 in 2004, unless a judge grants special permission. Still, about 42,000 requests to marry minors were made in 2009, mostly in rural areas.

Cambodian women were unable to mark the day publicly, as authorities banned a rally amid growing concern about a crackdown on freedom of expression in the country.

### If Fraud were a wild animal, what would he be?

FEBRUARY 19, 2011 A RED-LETTER DAY FOR 4,000 FILIPINOS – By an 85-5 vote, the new Constitution and Bylaws of the Filipino Association of Montreal and Suburbs (FAMAS) was ratified last February 19th, but not without acrimonious debates between a small group that wanted to postpone the ratification and a bigger group that was resolute to go ahead with it come hell or high water.

Right at bat, Fraud Crass Magallanes, the usual obstructionist, tried his darn best to derail the chugging ratification train by driving a wedge into its track with a point of order concerning the quorum. Citing Section 4, Article XVII of the old constitution and bylaws that states "Thirty percent of the regular members may request a special general assembly in writing and this percentage constitutes a quorum," he argued that since there were only about 100 members in attendance (out of 4.000). the assembly significantly fell short of the minimum 1.200 members required to have a quorum. Therefore, according to him, the ratification could not and should not proceed because doing so would be unconstitutional.

Apparently referring to the plain meaning rule of statutory interpretation, he reiterated at the assembly, as he did in his latest editorial, that the foundation of his argument was the "long-settled legal dictum that when the provision of the constitution is clear there is no need to interpret it." Obviously, Fraud doesn't know or has conveniently forgotten that there is another rule in statutory interpretation that takes precedence over the plain meaning rule. It's the Golden Rule, or British Rule, which states that the wording of the statute may not be honored when it produces an absurd or unreasonable result, calls for an impossible outcome, or yields an unconstitutional result.

If we followed the wording of the aforementioned Section 4 of Article XVII as Fraud insisted, the presence of at least 1.200 members would have been required to transact business legally. Hauling that many people in one place at the same time is absurd or unreasonable. That's one of the results referred to in the Golden Rule. And there's also the legislative intent. It's good that Rey Balansi, the lead framer of the controversial 2005 Constitution and Bylaws came forward and admitted that it was not their intention to make 1,200 members as the minimum number to constitute a quorum. So, in the final analysis, the recent ratification of the new constitution and bylaws is unconstitutional after all.

WHERE'S YOUR SENSE OF HISTORY? - Fraud questioned the proponents' sense of history for changing the old FAMAS logo that I once harshly criticized into one that is more meaningful and truly representative of all Filipino expatriates in Montreal and

Suburbs. He would rather keep the old logo, which I likened to a cistern with the half-submerged sun as the float and the red and blue field as the water that's waiting and ready for the next flush, than adopt Mr. Manny Coquia's winning entry which the Executive Board aptly nicknamed "The Shield" or "Ang Kalasag" in Pilipino.

As my counter-argument, I cited the Americans for having changed their flag many times already. Of all the peoples in the world, the Americans cannot be accused for not having a great sense of history because they do. And yet they didn't have any problem changing their flag from time to time because they were forward-thinking enough to go along with the evolution of their great country. I also made example of the Filipinos for the same reason. Our own "watawat" or "bandila" has been changed on many occasions from the time of Andres Bonifacio to the time of Ferdinand Marcos. And no one can say that Filipinos don't have any sense of history, except perhaps in the twisted mind of Magallanes.

MONCHING VICENTE SAVED THE DAY FOR FAMAS – What many FAMAS officers and members wouldn't touch with a ten-foot pole, Monching Vicente, armed with the gallantry typical of most Caviteños, embraced without any reservation. I am referring to the difficult and thankless job of presiding over the Special General Assembly that was called for the ratification of the now-ratified FAMAS Constitution and Bylaws. To his credit, Monching did not shy away from the daunting task he was asked to perform.

Despite the barrage of questions coming from Magallanes, Parado, Ogerio, Felix Reyes and Dick Dahiroc, Monching stood his ground, soldiered on and remained unfazed by all the diatribes from all those people, more especially Magallanes, Reyes and Dahiroc whom I now call the Marx Brothers of the community.

Monching was cool, collected and unflinching despite the harangues hurled at him by the new Marx Brothers. And most of all, to borrow the words of his brother-in-law Bert Santos, he delivered the goods - the newly-ratified FAMAS Constitution and Bylaws. Thank you, Monching, for absorbing all the shocks and taking all the heat for all of us who rather be in the audience. As far as I'm concerned, Monching is a hero. I'm sure that only Magallanes and his ilk will begrudge him that honor and distinction. But most members of the community don't give a damn whatever Fraud may do, say or write anymore. ### Questions & Answers About Our Environment

Dear EarthTalk: I heard someone say that the environmental benefits of natural gas for electricity generation were overstated and that it is not as green-friendly as the industry would have us believe. What is your take on this?

In our increasingly carbonconstrained world, natural gas (also known as methane) does keep coming up as a potentially cleaner fuel source for electricity generation than coal, currently the nation's primary source of electrical power. Natural advocates argue that it generates 50 percent fewer greenhouse gases than coal when burned. And since natural gas is more widely available than ever, thanks to newer more efficientthough in some cases environmentally damaging—extraction techniques, some think it should be playing a larger role in a transition away from coal, the dirtiest of all fossil fuels. Today over 50 percent of electricity generated in the U.S. comes from coal; natural gas accounts for less than 20 percent.

But scientists aren't so sure natural gas should play any part in solving the climate crisis. A 2007 lifecycle analysis of natural gas production, distribution and consumption found that when one factors in the total emissions associated with not only the end use of natural gas but also its extraction and distribution—much of it can leak when it is pulled out of the ground and then

piped to power plants and other customers—it doesn't seem so much cleaner than coal after all.

The U.S. Environmental Protection Agency (EPA) says that loose pipe fittings and intentional venting for safety purposes on natural gas lines cause annual greenhouse gas emissions rivaling that produced by 35 million cars each year. The World Bank estimates that emissions from natural gas extraction operations alone account for over a fifth of the atmosphere's total load of climate-changing methane.

"When scientists evaluate the greenhouse gas emissions of energy sources over their full lifecycle and incorporate the methane emitted during production, the advantage of natural gas holds true only when it is burned in more modern and efficient plants," reports Abrahm Lustgarten on the investigative news website, ProPublica. "But roughly half of the 1,600 gas-fired power plants in the United States operate at the lowest end of the efficiency spectrum."

He adds that, while the median U.S. gas-fired power plant emits 40 percent fewer greenhouse gases than a typical coal plant, some 800 inefficient plants offer only a 25 percent improvement. The fact that methane is an extremely potent greenhouse gas—the EPA says methane is 20 times more effective trapping heat in the atmosphere than carbon dioxide (CO2) —makes it even less appealing as a replacement for coal.


"The problem is you build a gas plant for 40 years," James Rogers, CEO of Duke Energy, one of the largest power companies in the U.S., told ProPublica. "That's a long bridge. What if, with revelations around methane emissions, it turns out to be only a 10 or 20 percent reduction of carbon from coal? If that's true, gas is not the panacea." Rogers himself is an advocate for limiting greenhouse gas emissions.

But with the Obama administration still keen on mining domestic natural gas reserves versus upping our reliance on foreign oil, natural gas will likely continue to play a role in the energy mix for some time yet.

Dear EarthTalk: Isn't it a waste that we buy water in plastic bottles when it is basically free out of our taps? Even health food stores, which should know better, sell it like crazy. When did Earth's most abundant and free natural resource become a commercial 'beverage'? -- A. Jacobs, via e-mail

Bottled water has been a bigselling commercial beverage around the world since the late 1980s. According to the Worldwatch Institute, global bottled water consumption has more than quadrupled since 1990. Today Americans consume over 30 billion liters of water out of some 50

billion (mostly plastic) bottles every year. The Beverage Marketing Association reports that in 2008 bottled water comprised over 28 percent of only bottled drinks Americans consume more of are carbonated sodas like Coke and Pepsi.

And frankly, yes, it is a ridiculous waste that we obtain so much of our drinking water this way when it is free flowing and just as good if not better for you right out of the tap. According to the Earth Policy Institute (EPI), some 2.7 million tons of petroleum-derived plastic are used to bottle water around the world every year. "Making bottles to meet Americans' demand for bottled water requires more than 1.5 million barrels of oil annually, enough to fuel some 100,000 U.S. cars for a year," says EPI researcher Emily Arnold. And just because we can recycle these bottles does not mean that we do: The Container Recycling Institute reports that 86 percent of plastic water bottles in the U.S. end up as garbage or litter.

The financial costs to consumers are high, too: According to the Environmental Working Group (EWG), bottled water costs up to 1,900 times more than tap water. And the Natural Resources Defense Council (NRDC) reports that 90 percent or more of the money consumers shell out for it pays for everything but the water itself: bottling, packaging, shipping, marketing, other expenses—and, of course, profits.

EWG is particularly appalled at the lack of transparency by leading bottled water sellers as to the sources

of their water and whether it is purified or has been tested for contaminants. According to a recent survey by the group, 18 percent of the 173 bottled waters on the U.S. market today fail to list the location of their source; a third disclose nothing about the treatment or purity of the water inside their plastic bottles.

"Among the ten best-selling brands, nine—Pepsi's Aquafina, Coca-Cola's Dasani, Crystal Geyser and six of seven Nestlé brands—don't answer at least one of those questions," reports EWG. Only Nestlé's Pure Life Purified Water "discloses its specific geographic water source and treatment method...and offers an 800-number, website or mailing address where consumers can request a water quality test report."

FWG recommends consumer resist the urge to buy bottled water and go instead for filtered tap water. "You'll save money, drink water that's purer than tap water and help solve the global glut of plastic bottles," the group advises, adding that it supports stronger federal standards to enforce consumers' right to know about what's in their bottled water besides water. Until that day comes, concerned consumes should check out EWG's Bottled Water Scorecard, a free website that provides information on various bottled water brands, where they originate and whether and how they are treated to remove contaminants.

#### SYSTEMIC/SYSTEMATIC

It is very easy to distinguish what is systemic and what is systematic. Perhaps

arose because of semantics, spelling and sound. The two words have almost the same letters nevertheless. It's just the addition of two letter "a" and "t" for systematic, which make it longer. The pronunciation is also the same but there's obviously an additional syllable for the word systematic.

By definition, the two adjectives differ. Systematic, means something is well organized or arranged according to a set of plan and or is grouped into systems. Conversely, systemic means something matters to the entire system. This describes something that belongs to, works together with, or can affect the entire body or system as a whole. The two words further amplify its definition when used to describe other terms across various fields of study. For business, there are systemic and systematic risks and also the accepted structures for the verb systemic and systematic circulations in the field of Science.

To concretely show the difference between the two adjectives, it is best to use them in sample sentences. In one common definition of Science (the study); it is regarded as a systematic and orderly arrangement of facts, principles, true happenings that governs our lives and the whole world. Science is systematic because it has order and its facts are arranged. You cannot say Science is systemic but Science is systematic for it readily follows a particular system or methodology. Thus, if you have a consistent method of cleaning the bedroom first, followed by the living room and lastly the dining room then more or less you can be described as cleaning your house systematically.

Systemic is very different because when the doctor tells his patient that he or she has a systemic lupus or a systemic infection then this means that the patient is experiencing a generalized infection all throughout the entirety of his or her body. The entire system (the human body) is affected that's why the case is already systemic. This also implies that the health prognosis is poor because the infection has spread.

In summary, the two words differ because: 1. Systematic is a longer word with four syllables compared to the shorter word (systemic) that only has three syllables.

2. Systematic is an adjective that's used to describe something as consistent, organized and well arranged whereas systemic means that something has or can affect the whole system.

I recently came across this sentence: We are responsible to ensure delivery of the program.

I thought that it would be better to write responsible for ensuring instead. What are the rules for using for and to with responsible?

Answer:

The sources we consulted (Canadian Oxford Dictionary, Collins Cobuild English Dictionary for Advanced Learners and The Dictionary of English Word Combinations) agree that the following are phrase "be responsible":

Be responsible for something or carrying out an action.

For example: We are responsible for ensuring ratification of the Constitution. (an action)

We are responsible for the program. (a specific thing)

Responsible to

Be responsible to a person or group of

For example: We are responsible to our clients (group of people) for the program.

The Filipino Star is responsible to its many readers for responsible journalism.

Responsible with

If you want your kids to be responsible with money, you have to be good with money yourself

Note, however, that be responsible to ensure is not wrong. Language evolves over time; what was once considered incorrect becomes acceptable. A quick check in Google revealed 82,800 hits for responsible to ensure and a whopping 970,000 hits for responsible for ensuring.

#### **BORN/BORNE**

This distinction is a bit tricky. When birth is being discussed, the past tense of "bear" is usually "born": "I was born in a trailerbut it was an Airstream." Note that the form used here is passive: you are the one somebody else-your mother-bore. But if the form is active, you need an "E" on the end, as in "Midnight has borne another litter of kittens in Dad's old fishing hat" (Midnight did the bearing).But in other meanings not having to do with birth, "borne" is always the past tense of "bear" "My brother's constant teasing about my green hair was more than could be borne.

#### CUT AND PASTE/COPY AND PASTE

Because "cut and paste" is a familiar phrase, many people say it when they mean "copy and paste" in a computer context. This can lead to disastrous results if followed literally by an inexpert person. If you mean to tell someone to duplicate something rather than move it, say "copy." And when you are moving bits of computer information from one place to another the safest sequence is often to copy the original, paste the copy elsewhere, and only then delete (cut) the original.

For the past six months, 27-year old Arcie G. Mallari has been volunteering at the Philippine Community Center. Twice a week, he teaches Heritage classes to the children and provides leadership training to the youth in connection with FAMAS Pagsibol project

Unfortunately, Mallari is going back to the Philippines next month. He came to Montreal last August as a scholar of Sauve Scholar Foundation, a project of former Governor General of Canada Jeanne Sauve. Launched in 2003, the goal of SSF is to help young leaders all over the globe who want to change the world.

Chosen from among 1,000

applicants from all over the world, Mallari is one of the 14 recipients of scholarship and the first Filipino to receive this honor.

My project is to design and plan Super Kids: Create Heroes, be a Hero! modules for its and to train

in the field of children and vouth's development for twelve years now. He is not only the president but also one of the three founders of Silid Aralan, Inc. (SAI) or "Learning Room" that started in April 2, 2007. Its goal is to strengthen the educational services of underprivileged public school students in Rodriguez (Montalban), Rizal,

Mallari recalled the day he visited one of the dumpsites in the Philippines. called Pavatas, to teach religion. But he did more than teaching religion when he saw the plight of children and youth. After graduating from the Polytechnic University of the Philippines with a BA in Political Economy, he decided to live in the dumpsite to be close to the people there.

"I witnessed children and youth scavengers," said Mallari. "My life became intimately intertwined with the lives of young men and women who lived on poverty. There, I met youth who dreamed of being jeepney drivers and women who wanted to become housemaids. I also met high school students who could not read or comprehend their textbooks. All of these inspired me to create advocacy and develop unique educational programs."

Mallari's endeavour paid off when three years later, the first set of scholars graduated. One of them is Romanicnic, who aspired to be a housemaid. After graduating from college and landing a job, she was able to take her family out of the dumpsite to live a decent life.

But it was not a smooth sailing for in the beginning. Mallari and the other two founders were questioned about their qualifications because none of them were trained in education. For example, Mallari is a graduate of political economy. In addition, fund raising was difficult. Prospective donors hesitated to invest in low-performing students. Also, SAI had difficulty convincing parents of students to

facilitators, 'said Mallari, 'The focus is on developing skills and confidence through heroism. Why heroes? Heroes achieve success by believing in power of ideas, having the confidence to take risks and to persevering and overcoming

Mallari was chosen because of his impressive background. He has been believe that their children are intelligent and can make a difference in the community

"We give importance to value formation,"said Mallari."If a student loves what he does, it will help him get good grades in school.

Now, SAI, in partnership with the local government, corporations and other

local businesses, has changed the lives of underprivileged academically-challenged students in the Philippines. No longer low-performing students, they are now academic achievers

Building ten Silid Aralan centers, training around 5.000 students, employers and volunteers nationwide, mobilizing 500 volunteers and affecting parents thousands of children is daunting. Throughout these programs, like SAI, Mallari's greatest accomplishment is

leading the way towards empowerment, creating heroes and mobilizing others to educate and empower the children.

#### Ataxia: it's time to talk about.

Helen has an unstable step and uncoordinated movements. When walking, she limps. When standing still, she trembles and swavs. At some point, perhaps in a few months or sometime this year, Hélène will start using a cane, a walker, or a wheelchair. But today, she's encountering mocking and scornful looks, and enduring comments made audibly behind her back: "That girl has obviously had too much to drink. '

Helen suffers from a rare medical condition. one of the numerous forms of ataxia. But she's also suffering from the lack of sympathy and understanding of those she encounters every day.

Familial ataxias are comprised of diseases of the nervous programmed into the genetic code. Forms of ataxia are distinguished by various symptoms and handicaps, but all those who suffer from ataxia share a lack of coordination of voluntary movements. These diseases are progressive and involve a gradual loss of physical faculties, often until the sufferer is rendered a complete invalid. Familial ataxias can manifest themselves at any point during the life of an individual, sometimes very suddenly, without any discrimination of age. Anybody can be a victim. There is no cure Do you know someone suffering from ataxia?

There may be some individuals in vour community in Montreal, or in Quebec, or anywhere else in Canada. They all have to deal with the mocking looks, and the lack of sympathy and understanding experienced by Helen. They suffer despite the sympathy of those close to them, and often end up alienating their friends and isolating themselves to avoid misunderstanding.

There is a general lack of information regarding rare diseases, and ataxia in particular. The Canadian Association of Familial Ataxias (CAFA) has been raising awareness for more than 38 years. CAFA was founded in 1972 by Claude St-Jean, who suffered himself from Friedreich's Ataxia. He was an example of courage, determination, and tenacity his whole life, and knew how to inspire hope for those suffering from ataxia, those who were handicapped and sick. He was a source of inspiration for everyone, no matter what their physical condition.

Today, like yesterday, CAFA is a small team devoted to the help and comfort of ataxic people and financing medical research. Please help them win the fight against familial ataxias!

### Reasons to Upgrade to a DSLR (Digital Single Lens Reflex) Camera

Ever since the DSLR camera were introduced, I was sKeptic about its use in the professional level. Meaning using these cameras to shoot video even at 1080i (High-Definition Television Video Mode) wide screen aspect ratio of 16:9 with a frame size of 1920x1080 pixels.

My main reason is that these cameras have a limit amount of storage space on their memory stick and cannot last on a full days wedding compared to a dedicated video camera using DV tapes. Another reason is that the audio is not reliable to have a clean signal because there is no XLR input to the body of the camera.

At WEVA (Wedding Event Videographers Associations) Convention held at Orlando, Florida held last summer, there were huge amount of talks and seminars about DSLR. Then I saw stunning footages of wedding Same-Day-Edit by Jason Mayuga from the Philippines because he was one of the star speaker of the convention. I crave for more information.

My conclusion was DSLR should be used only for journalistic approach of wedding such as SDE (Same-Day-Edit) or short film scenario when you need to control exposure values, depth of field and enhancing colors. The rest of the shoot should be done with standard video camera and just edit them to make a story

Here are the reasons for upgrading to DSLR

1. Image Quality - Due to the larger

size of image sensors in DSLRs which allows for larger pixel sizes – DSLRs are generally able to be used at a faster ISO which will lead to faster shutter speeds and less grain (ie shoot at 1600 ISO on most DSLRs will have less noise than shooting at 1600 on a Point and Shoot). DSLRs also have built in noise-reduction when generating JPG images which also helps cut down on noise.

2. Adaptability - DSLR's ability to



change lenses opens up a world of possibilities for photographers. While my point and shoot has a nice little 3x Optical Zoom (and many these days have longer ones) my DSLR can be fitted with many high quality lenses ranging from wide angle to super long focal lengths depending upon what I'm photographing (and of course my budget). Add to this a large range of other accessories (flashes, filters etc) and a DSLR can be adapted to many different situations. It should be noted that when it comes to lenses that the diversity in quality of lenses is great. Image quality is impacted greatly by the quality of the lens you use.

3. Speed – DSLR's are generally pretty fast pieces of machinery when it comes to things like start up, focusing and shutter lag.

4. Optical Viewfinder - due to the reflex

mirror DSLR's are very much a what you see is what you get operation.

 Large ISO range – this varies between cameras but generally DSLRs offer a wide array of ISO settings which lends itself to their flexibility in shooting in different conditions.

6. Manual Controls – while many point and shoots come with the ability to shoot in manual mode, a DSLR is designed in such a way that it is assumed that the photographer using it will want to control their own settings. While they do come with good auto modes the manual controls are

generally built in in such a way that they are at the photographers finger tips as

they are shooting.

7. Retaining Value – some argue that a DSLR will hold it's value longer than a point and shoot. There is probably some truth in this. DSLR models do not get updated quite as often as point and shoot models (which can be updated

twice a year at times). The other factor in favor of DSLRs is that the lenses you buy for them are compatible with other camera bodies if you do choose to upgrade later on (as long as you stay with your brand). This means your investment in lenses is not a waste over the years.

8. Depth of Field – one of the things I love about my DSLR is the versatility that it gives me in many areas, especially

depth of field. I guess this is really an extension of its manual controls and ability to use a variety of lenses but a DSLR can give you depth of field that puts everything from forground to background in focus through to nice blurry backgrounds.

9. Quality Optics – I hesitate to add this point as there is a large degree of difference in quality between DSLR lenses but in general the lenses that you'll find on a DSLR are superior to a point and shoot camera. DSLR lenses are larger (more glass can add to the quality) and many of them have many hours of time put into their manufacture (especially when you get into higher end lenses).

And for those who are eager to buy these toys I strongly advice DSLR buyers to buy the best quality lenses that they can afford. It's the difference between a high end lens on a medium range camera or a medium range lens on a high end camera I'd go for quality lenses every time as they add so much to photos.

- Combat gender inequality in general, and the incidence of poverty in particular, by addressing the intersectional dimension of disadvantaged women - the unique circumstances and systemic inequality of ethno-cultural, racialized, immigrant, and disabled women:
- Establish a comprehensive and coordinated affordable and adequate housing strategy for the four million Canadians, a disproportionate number of whom are single older women, single mothers, aboriginal women, and immigrant women;
- Combat international violence against women, including, in particular the trafficking of women and girls - the new global slave trade - the fastest growing criminal industry in the world and the growing crisis of violence against women in armed conflict;
- Enhance the government's maternal health initiative in developing countries so as to support access to family planning and reproductive health services.

Since his election to Parliament in 1999, Prof. Cotler has been the longest serving male member of his Party's women's caucus.

Corned Reef Hash

#### Ingredients:

- 1 Can of Corned Beef
- 2 Small sized potato, diced in 1/4
- 1 Small onion, sliced thinly
- 1 Small bay leaf
- 2 Cloves of garlic, smashed
- 1 Teaspoon MSG

Salt & Pepper to taste (S&P)

#### Directions:

In a skillet saute garlic until golden brown and then add onion and cook until it hits the shiny stage. Add corned beef and break it apart. Cover and let it cook for 3 minutes on medium low heat. Add potatoes, bay leaf, MSG, and pepper. Stir, cover, and let it simmer for 12 more minutes on medium low heat. Stir again and add salt just before serving. Enjoy!



Filipino style corned beef hash sandwich

- 1 can corned beef,
- 1 small onion, finely diced
- 2-3 small red or yellow potatoes olive oil and unsalted butter sea salt and freshly ground black pepper to taste

Peel the potatoes and boil them until they are fairly cooked but not mushy. Cook them unpeeled, if you prefer. Set aside to cool and then finely dice the potatoes.

Heat the olive oil and butter in a large pan or skillet over medium-high heat. Sauté the finely diced onions until soft. Add the potatoes and corned beef. Add salt and pepper to taste. Stir well, lower the heat, cover the pan and cook for 5 minutes. Uncover, stir, cover again, and cook for another 5 minutes.

If you prefer your corned beef hash crusty, raise the heat to mediumhigh and cook uncovered. Stir. let the hash sit for a while and then stir again and continue cooking until it becomes crusty but not burned.

- \* 2 tablespoons butter
- \* 1 onion, chopped
- \* 2 cloves garlic, minced
- \* 4 carrots, sliced
- \* 2 cups chopped green cabbage
- \* 1 pound diced cooked corned beef
- \* 3 tablespoons flour
- \* 1-1/2 cups beef broth
- \* 1/3 cup ketchup
- \* 2 tablespoons mustard
- \* 2 tablespoons Worcestershire sauce
- \* Salt and pepper to taste
- \* 3 cups water
- \* 3 tablespoons butter \* 1/2 cup milk
- \* 3 cups instant mashed potato flakes
- \* 1/3 cup sour cream
- \* 1/2 cup grated Parmesan cheese
- \* 1 cup frozen baby peas, thawed
- \* 1/2 teaspoon paprika

#### Preparation:

Preheat oven to 375 degrees F. In large skillet, melt 2 tablespoons butter over medium heat. Add onion and garlic; cook and stir 4-5 minutes until crisp-tender. Add carrots; cook

and stir 4 minutes. Then add cabbage: cook and stir 4-5 minutes until crisp-tender.


Add corned beef; cook and stir for 3 minutes. Add flour: cook and stir for 3 minutes. Add broth, ketchup, mustard, Worcestershire sauce, and salt and pepper to taste; simmer 10 minutes

Meanwhile, combine 3 cups water, 3 tablespoons butter, and 1/2 cup milk in large saucepan; bring just to a boil. Remove from heat and beat in potato flakes until combined. Add sour cream and Parmesan cheese.

Add peas to beef mixture and pour into 3 quart casserole dish. Top with mashed potatoes and spread to cover, then run a fork over the potatoes to make shallow furrows. Sprinkle with paprika.

Bake for 25-35 minutes until filling is bubbly and potatoes are golden brown. Let cool 10 minutes, then serve. Serves 6

#### Libya: Médecins Sans Frontières is extremely concerned with the plight of the wounded; calls for unhindered access to medical care.

Geneva, 12 March 2011 – As conflict intensifies inside Libya, the international medical humanitarian organisation Médecins Sans Frontières (MSF) is extremely concerned with the situation of the wounded caught in the middle of violent clashes, and calls for urgent unhindered access to medical assistance, irrespective of any political considerations.

For the past three weeks, the MSF teams based on the Tunisian border and in Benghazi have been providing medical supplies to health facilities in Libya and actively working to access areas in the western part of the country, where violent fighting is taking place.

In several conflict zones, such as Zawiyah and Misrata, large numbers of people are cut off from any external assistance, while critical medical needs and shortages of medicine and materials are reported.

"We are deeply concerned with the denial of access to medical care and the plight of patients in public health facilities within government-controlled areas", says Bruno Jochum, director of operations at MSF.

### Montrealers defy frigid temperatures to celebrate International Women's Day

Montréal, Québec -- On Tuesday, 8th March 2011, Montréalers took to the streets to celebrate International Women's Day. Despite freezing weather condition, close to 400 Montréalers marched along Ste-Catherine street, in the downtown heart of the city. The demo organized for the tenth year in a row by the 8th March Committee of Women of Diverse Origins drew in an array of groups, some of whom are members of the 8th March Committee - PINAY (the Filipino Womens' Organization in Québec), the South Asian Women's Community Centre, the Immigrant Workers' centre, the Iranian Women's Association, Proletarian Feminist Front, and the Movement Against Rape and Incest. There were many women joined by male supporters and allies. The were elders and many youth. The groups represented local and international issues - Palestine, aboriginal women who have been disappeared, working-class women of Montréal, migrant workers from the Philippines and Latin America, violence against women, students and workers.

Catching many eyes along the route of the demonstration were large cut-outs of women with their arms raised, trailing brightly-coloured ribbons of fabric. They symbolized uprising to make real the slogan for this year in Montréal, "The Slaves of

reaffirms the importance of being able to respond effectively to the people's urgent medical needs, regardless of their side or origin.

"Our main challenge today is to gain immediate access to the people affected by violence inside Libya", continues Bruno Jochum. "Despite ongoing intense fighting, our medical teams, which have been deliberately blocked at the Tunisian border in Ras Ajdir for weeks now, do not see any injured patients authorized to cross into Tunisia. It is essential that people have the possibility to flee combat zones to find refuge in safe areas inside Libya or abroad."

Following medical ethics and international humanitarian law, it is crucial that all belligerent parties respect medical facilities, vehicles and personnel, as it is the only way patients will receive the urgent medical care they need.

MSF continues to assist the civilian population through the delivery of medical supplies in Libya. Since the first MSF team was able to enter eastern Libya on 24 February, twentywo tons of medical supplies have been distributed in the areas where the most acute needs have been identified. the Slaves Rise Up!" an historic slogan adopted by women struggling for change and equality in different parts of the world at various historic junctures. ### Thia Megia reminds "Idol" judge of Michael Jackson

MANILA, Philippines – Fil-Am Thia Megia has just gotten what may be one of the biggest compliments ever given by an "American Idol" judge to a contestant.

During the semifinals held March 2 that featured the Top 24 contestants, record producer Randy Jackson did not hide his astonishment at the quality of Megia's voice, which reminded him of King of Pop Michael Jackson.

He added that although he, Jackson and Lopez selected "so many people that are so good it's gonna be hard for the American public to pick," Megia "[made] it easy for [me]" because of her performance.

# Luis clears mom Vilma's involvement in car ambush

Luis Manzano clarified speculations that his mother, Batangas Governor Vilma Santos-Recto, was the target of a car ambush that killed her executive assistant and his driver last March 12.

The TV host-actor told "The Buzz" on March 13 that he had spoken with his mother about the incident.

"Tinawagan ko 'yung mommy ko... habang ongoing ang 'E-Live.' Tinanong ko [siya], 'Nangyari ba na ikaw 'yung target na may nadamay lang?' Sabi niya hindi talaga. Sabi niya, 'Ako pauwi. Completely iba ang pupuntahan nila.' So, I guess iba 'yong rason kung bakit nangyari 'yon. I don't think may kinalaman sa mommy ko," Manzano related.

Text messages and online posts circulated earlier alleging that Santos-Recto was victimized in the ambush. Luis dispelled the rumor on "E-Live" Saturday.

"I just want to clarify na hindi po totoo na ina-ambush ang mommy ko. Ang unfortunate incident po ay nangyari po sa kanyang executive assistant," he said.

Manzano reiterated in his interview with "The Buzz" that the actress-politician is "a-okay." He also wished that "justice be served" for the victims of the ambush namely Cesar Guce, Santos-Recto's executive assistant and the supervising administration officer in Batangas' budget office, and his driver Randy Reyes.

The two, together with a 17-year-old boy, were heading to Cuenca, Batangas aboard a Toyota Land Cruiser when three masked men on a motorcycle fired at them along Barangay Banay-Banay at around 6:30 a.m. Sunday, reported ABS-CBN News.

The vehicle, according to witnesses, then lost control and smashed into a watermelon stall. The boy reportedly survived the grim incident but Guce and Reyes did not even when reportedly rushed to the Mary Mediatrix Hospital by bystanders.

Santos-Recto was "shocked" at what happened to her executive assistant.

"He's a good man at wala akong alam na dahilan para siya patayin," she told ABS-CBN News.

While Manzano thinks the motive behind the ambush was likely "personal," the Batangas governor is clueless if the incident involved work.

"I have no idea kung may nasasagasaan siya sa trabaho niya, and knowing him, he's not the type na nakikialam sa interes ng ibang tao," she said.

The Batangas police, headed by Senior Superintendent Albert Supapo, has launched a special task force to investigate the incident upon Santos-Recto's orders.

"Hindi ko sila pababayaan, gagawin ko ang lahat para mahuli ang mga gumawa sa kanila ng bagay na ito," said the governor.

Antonio Laroya, Arnisito Gaviola and Ermie Zotomayor were making \$10 an hour at the Thompson gas bar until they were arrested last summer for working without valid work permits. They were laid off from jobs in Alberta and said they were told by their new employer in Manitoba he'd take care of the labour market opinion and other documents needed to restore their work permits. Meanwhile, Canada Border Services Agency investigators declared they'd been watching them work in March and April. They didn't counsel them on what was legally required of them. Their 90 days' grace expired in May, and the Filipino foreign workers were arrested in June by police.

admissibility Their Wednesday was put over to March 15, when the three Canada Border Services Agency investigators can appear in court. The three men's status remains in limbo and they can't work to support their families in the Philippines or themselves. They're getting financial help and moral support from friends, church groups and Filipino labour organizations like Damayan Manitoba and Migrante Canada.

The men came to Canada from the Philippines after paying recruiters hefty fees to work in low-paying service jobs in Alberta. When they were laid off, they had 90 days to restore their work permits but were ineligible for benefits from the Employment Insurance to which they'd contributed. They found jobs in

The Three Amigos, like many low-skilled temporary foreign workers, were caught in a jam, Matas said at press conference after court.

"What we're seeing now is the problem of abuse of migrant workers." he said. Matas said workers are paying placement fees when they should not be charged. "You shouldn't have to pay to get a job," said Matas, adding foreign workers are also being exploited by employers when it comes to transportation costs.

The employer is responsible for their airfare home at the end of their contract but the workers are laid off and the cost is passed along to the next employer. "It creates a termination incentive '

but it puts them in a vulnerable position. With no income, they have to find work, apply for the work permit and hope their employer is registered in Manitoba to hire temporary foreign workers and fills out their end of the paperwork. "These people were trying to deal

with the system as best they could," Matas said of the three Filipino men. "It shouldn't have happened this way." The border services agents should have said "stop" and told them the proper procedures to follow, not lain in wait for them, he said.

He's hoping the Filipino men receive temporary residence permits that will allow them to stay in Canada to get their affairs and work permits in order. "We are frustrated," Gaviola said at the news conference. "We've been waiting a long time since we (were) arrested. Our families in our country are affected."

He said his family back home is down to two meals a day, and they can't afford to buy the youngest one milk. Instead, they rely on water.

At one point, he felt like giving up and returning to the Philippines but, with extremely high unemployment there, he wants to stay and work in Canada

A worried Sam Milby immediately called up international singer Marié Digby upon learning that a magnitude 8.9 earthquake struck Japan on March

"All my friends are reaching out to me because all of the cellphone lines were down and no one could get in touch with us. Sam is one of the people who reached out and made sure that I was okay and my family was all right," Digby related in an exclusive interview by ABS-CBN News on March

Recall that Milby admitted last year that he and Digby used to date, but decided to remain good friends because of distance. He's based in Manila, while she shuttles back and forth from Los Angeles to Tokyo.

Apparently, Digby was in Tokyo that time. The former Youtube sensation revealed that she and her mother were inside an elevator when the ground started shaking.

"We were lucky to be in a secure building but many people weren't and they ended up dying either in the earthquake or as a result of the tsunami," Digby continued.

Asked how she felt then, the American-Irish-Japanese singer said,

"It's kinda like panic, but at the same time you're in survival mode. It's a feeling I've never had before and I'm just really, really grateful that we were unharmed.'

Digby also managed to document the earthquake as it happened via tweets she posted Friday afternoon.

"woaaaa!! big earthquake in tokyo!!! still moving here... starting to hear sirens outside... :/ we are fine here though....'

we just had a big earthquake!! 7.0 !! my building is still shaking !"

"we are still shaking. We ve been advised to remain in our building however. We are safe. praying for everyone in Japan #prayforjapan"

Arriving in Manila Monday morning, the 27-year old singer is in the country for a project. According to her, Milby was one of the people of convinced her to do a project here.

After her job here is done, Digby

intends to focus on coming up with ways to help her countrymen.

"I'm really coming to the Philippines with a heavy heart because my heart is still back in Japan for the people who lost their homes, their lives, their friends and families.

"So it's my goal, as soon as everything settles, to figure out how I can give back to my community and how I can help all the people who were part of the destruction," said she.




