Quebec's future is at stake on April 7

Philippines offers U.S. forces access to military bases

MANILA (Reuters) – The Philippines has agreed to allow the United States access to its military bases under a new security deal being negotiated by the two allies, amid mounting concern over China's increasing assertiveness in the disputed waters of the South China Sea.

The offer was made during a sixth round of talks held in Washington last week, Filipino officials said on Friday. The two sides hope to finalize terms before U.S. President Barack Obama embarks on a visit to Asia, including the Philippines, next month.

"Consensus was arrived at on many provisions of the draft agreement," Pio Lorenzo Batino, defense undersecretary told a news conference, adding the deal is 80 percent done.

"The proposed agreement will allow the sharing of defined areas within certain AFP (Armed Forces of the Philippines)facilities with elements of the U.S. military."

The United States plans to "rebalance" its forces in Asia-Pacific region, and has similar arrangements with Australia and Singapore, as part of its strategy to counter China.

Manila would welcome the return of a U.S. military presence to deter China's ambitions in the South China Sea, and to help provide humanitarian assistance during natural disasters.

"It will not stop China from its bullying tactics, but it will become more cautious and might exercise self-restraint due to the U.S. presence," Rommel Banlaoi, an analyst at Philippine Institute of Peace, Violence and Terrorism Research, said.

"The Philippines will also benefit from more exercises and more assistance from the U.S. and it will elevate the Philippines to a major non-NATO ally in the Pacific."

Friction between China and the Philippines and other states in the region, over disputed territories in the South China Sea has increased since last year despite diplomatic efforts to forge an agreement on maritime conduct.

The dispute revolves round competing claims over the Spratlys, a group of 250 uninhabitable islets spread over 165,000 square miles.

On Sunday, three Chinese coast guard ships stopped two Filipino civilian

The new agreement on enhanced defense cooperation will allow the United States increased deployment of troops, ships, aircraft and humanitarian equipment.

U.S. military access in the Philippines is currently limited to during annual joint-exercises and port visits. The Philippines kicked the United States out two large military bases, including Subic Bay, in 1991.

While that ended a special relationship going back 40 years between the United States and its former colony won its independence in 1946, an alliance has endured.

vessels from delivering food, water and construction materials to troops based on a ship that was deliberately run aground on reef in the Spratlys in 1999 to reinforce the Philippines' claim.

Manila called the Chinese actions "a clear and urgent threat to the rights and interests of the Philippines".

Under the draft accord, the Philippines will allow U.S. forces joint use of facilities in several military bases like Manila, Clark, Palawan, Cebu, Nueva Ecija, and La Union, a military official with knowledge of the negotiations.

"We are only offering U.S. military

forces access to fewer military bases," Ambassador Eduardo Malaya, a member of the panel negotiating with the Americans, said.

Manila refused a request for use of civilian airfields and ports, like Subic Freeport Bay, Laoag and Davao international airports, according to the military official.

Batino said the agreement will be legally binding but will not require ratification by the Philippine Senate, which could delay the actual U.S. deployment.

Lee was charged with syndicated estafa, a nonbailable offense, in connection with two housing projects in Pampanga province. He was accused of using fictitious members of the Home Development Mutual Fund (Pag-Ibig Fund), a government program, to obtain housing loans – totaling P6.6 billion – that he used in GlobeAsiatique's Xevera subdivisions in Bacolor and Mabalacat towns of Pampanga between 2008 and 2011.

Lee pulled the scam by using nonexistent or fake homebuyers and paying them to apply for Pag-Ibig home loans. After the homes were built, GlobeAsiatique would then sell them to other homebuyers who would discover

But no sooner had Lee been in police custody than a series of unusual events started to happen. They just lie there and they die there

March 25, 2014 ON DISTANT SHORE

Two feisty woman officials reminded us last week why campaigns against corruption in the Philippines never succeed. They don't succeed because after the corrupt acts are exposed and publicized, there is no follow-up, much less prosecution of the accused.

Chairman Grace Pulido-Tan of the Commission on Audit (COA) has ordered the agency's officials to monitor compliance with recommendations contained in annual audit reports to ensure that government agencies and institutions take them seriously and act to implement such corrective measures.

Tan hopes the new system would put an end to auditors reporting the same recurring problem every year because there are no follow-ups recommendations. Audit findings will then not suffer the same fate as dreams in the song "Mona Lisa," Tan said, where they "just lie there and die there."

Sen. Miriam Defensor Santiago, on the other hand, is exasperated that no charges have been filed in court against those named in numerous exposes and Senate committee hearings, and said the Ombudsman should start filing cases against those implicated in the P10-billion pork barrel scam.

"Since it has been six months. I think it would be best if the Ombudsman could at least file some of the cases in court now because the public are getting jaded with these public revelations in the Senate probe plus they are not seeing any action," Santiago said. "We don't want public interest to die on this matter because it's just too important. Plunder is just too important to the national economy.

wonders why despite voluminous evidence and the many witnesses who have willingly testified to the extent of the corruption involving the Priority Development Assistance Fund (PDAF) or the congressional pork barrel, the Disbursement Acceleration Program (DAP) or the presidential pork barrel, the Malampaya Fund and several programs of the Department of Agriculture and the Department of Agrarian Reform, the Ombudsman has not filed any formal charges before the Sandiganbayan against those implicated in the shameless

Are the exposes being squeezed dry by the administration and its allies to damage the reputation of some leaders of the opposition and possible contenders for either the presidency or the vice presidency? Is the Aquino administration really serious in prosecuting the big fishes in these scams regardless of party affiliations, or will these scandals go the way of previous corruption scandals that have been left unresolved?

Let us look at the numerous corruption scandals that have shocked the nation in the last few years, but have remained

The P200-million Jose Pidal case, wherein Sen. Panfilo Lacson accused Mike Arroyo of amassing more than P200 million from campaign contributions of her wife and putting the money in secret bank accounts, including that of "Jose Pidal"; the \$503-million Northrail project, which former Senate President Franklin Drilon described as one of the "colossal deals" of the Arrovo administration; the \$329-million National Broadband Network; the \$466-million Cyber Education Project; the P728-million fertilizer fund scam; the still to be probed P3.1-billion irrigation project just before the 2004 elections whose funds the Kilusang Magbubukid ng Pilipinas claims were diverted to the campaign; the P455million ice making machine scam also under the Department of Agriculture; the P5-billion swine scam; and the P120million Ginintuang Masagani Ani (GMA) project scam.

Add to these the P10-billion pork barrel scam, the P900-Malapampaya fund mess, the billions DAP funds illegally doled out to senators and congressmen before, during and after

impeachment trial of Chief Justice Renato Corona, and the billions more in agriculture funds that were allegedly coursed through fake NGOs.

In most of these cases, the culprits remain free, the whistleblowers have either been silenced or are now six feet under, and only the case against Abalos and Neri in the NBN-ZTE deal has been filed by the Ombudsman, and the Executive Department has blocked investigations by fraudulently invoking executive privilege.

The only case that landed in court - the \$2-million bribery case against former Justice Secretary Hernani Perez was obviously mishandled Ombudsman and was dismissed two vears ago.

All these corruption scandals hogged the headlines for days, only to die down when another scandal, either in government or in show business, displaced them on the headlines. In the Philippines, corruption scandals are never resolved; they just fade away.

Or as the COA chief said: "They just lie there, and they die there."

least several decades but remained to be virtually "invisible" in the political scene. Couillard instead challenged Marois to tell Quebecers how many women were going to be fired as a result of the charter, which bans the wearing of overt religious symbols among public service workers.

acclaimed not only locally but also internationally.

Vincent Villanis, a young entrepreneur who used to be a troubled youth was able to change and became engaged in developing a new product distilling beer from bamboo. His company produces, and distributes bamboo beer to restaurants and bars. This beer is not yet available in grocery outlets.

But, alas, Capa couldn't be farther from reality or to be more precise, realpolitik. What happened next stunned Capa and baffled many people. There was simply no reason why Capa's boss, PNP Chief Purisima, would abruptly transfer him one week after Lee's capture, to Cebu as Deputy Regional Director for Operations. In a press briefing, Purisima defended his action saying that Capa's relief was not a punishment but a reward, a promotion. He said that Capa had been in the task force for a long time and was now due for a transfer. He added that the new assignment would give Capa a chance for a promotion to one-star general.

But Capa had none of that. Caught by surprise, he was frustrated by the sudden turn of events. He felt that his transfer was not a commendation for a job well done. He said that every officer in the PNP knows it's not a promotion. Capa said that if Purisima had wanted to promote him, there were several vacant positions in Camp Crame, PNP's headquarters, he could have been assigned to.

So, if it was not a commendation or reward, what was it then? Could it be that Lee's arrest and the subsequent intervention of Umali had any bearing on Capa's relief? Or could it be that Purisima punished Capa for reportedly leaking the information that Umali had called Purisima to intervene on behalf of Lee? Capa was suspected of spreading rumors that Umali had pressured Purisima to release Lee. But Capa denied that he was the one who leaked the information on Umali's communication with Purisima. But regardless of who had leaked the information, the fact that Umali had indeed called Purisima on behalf of Lee's lawyer, makes one wonder why would Lee's lawyer break protocol on matters that should have been done through official channels?

At the end of the day, Capa's "problem" with his boss Purisima might not have been due to whether he leaked the Umali-Purisima telephone conversation or not. His fate may have been sealed the moment he captured Lee. He had stepped on big toes.... very big toes. And in military-oriented organizations like the PNP, when you step on big toes, you are punished by being kicked upstairs; that is, you're assigned to a new job that seems to be more powerful but is actually less powerful, which makes one wonder: was Conrad Capa kicked upstairs?

Dear EarthTalk: If "cap and trade" has worked so well in Europe for reducing greenhouse gas emissions there, why haven't we tried something similar here in the U.S.? — Sandra M., Bern, NC

"Cap-and-trade," whereby big polluters must pay to emit greenhouse gases against a capped total amount that is reduced over time-has been in effect across the European Union (EU) since 2005. This so-called Emissions Trading System (ETS) requires 11,000 of the largest electric and industrial facilities in 28 European countries to participate. Some 45 percent of Europe's total greenhouse gas emissions are regulated under the system. Proponents say the ETS has succeeded in keeping greenhouse gas emissions in check and making Europe a global leader on climate. The EU reports that, by 2020, emissions from sectors covered by ETS will be 21 percent lower than they were in 2005 and 43 percent lower by 2030. But critics argue that Europe's reduced emissions may be more due to the global recession than the ETS,

and that the cheap availability of allowances has made it easier for companies to pay to burn coal than to switch to cleaner natural gas or invest more in carbon mitigation technologies. Early in 2014 the EU

tightened up its system by cutting the number of new allowances it plans to issue over the next three years

by a third while simultaneously creating a "market reserve" to absorb extra allowances as needed.

Meanwhile, Switzerland, New Zealand, Australia, Kazakhstan and South Korea have each set up their

own national cap-and-trade programs to varying degrees of success, while regional versions have popped

up within Japan, Canada and the U.S. As to the U.S., whether or not to establish a nationwide cap-and-trade system here has been a hot topic of

discussion in Congress. It last came up for a vote in 2010, but never found enough bi-partisan support to

become the law of the land. But in lieu of any federal system, two U.S. regions have undertaken their own attempts at ratcheting down greenhouse gas emissions through market mechanisms:

In 2009, 10 Northeastern states came together to create the Regional Greenhouse Gas Initiative (RGGI), a capand-trade system with the goal of reducing regional carbon emissions from the power sector

10 percent from 2009 levels by 2018. Lower emissions than expected over the first five years of the program—thanks to

many utilities switching over to cleaner burning and increasingly cheaper natural gas as well as less overall economic output due to the recession—led RGGI to lower its overall annual cap from 165 million to 91 million tons in 2014, with a 2.5 percent reduction every year thereafter until 2020.

Analysts expect this rejiggering will drive the price of polluting five times higher than it has been and thus force utilities across the region to seek cleaner, greener alternatives to coal as an electricity feedstock.

The other major U.S. cap-and-trade player is California, which launched its own ETS in 2013 with a cap set initially at two percent below 2012 emission levels. The cap will then be reduced three percent a year

from 2015-2020. Some 600 facilities are big enough polluters to qualify for participation in the system, which will cover around 85 percent of the state's total greenhouse gas emissions. Given that California in and of itself is the 12th largest economy in the world, its forward-thinking commitment to cap-and-trade gives hope everywhere to fans of marshalling market forces to bring about environmental change.

Dear EarthTalk: Should those of us who care about our health and the planet be concerned about the new trend in genetic engineering called synthetic biology?

"Synthetic biology" (or "synbio") refers to the design and fabrication of novel biological parts, devices and systems that do not otherwise occur in nature. Many see it as an extreme version of genetic engineering (GE). But unlike GE, whereby genetic information with certain desirable traits is inserted from one organism into another, synbio uses computers and chemicals to create entirely new organisms.

Proponents of synbio, which include familiar players such as Cargill, Br, Chevron and Du Pont, tout its potential benefits. According to the Synthetic Biology Engineering Research Center (SYNBERC), a consortium of leading U.S. researchers in the field, some promising applications of synthetic biology include alternatives to rubber for tires, tumorseeking microbes for treating cancer, and photosynthetic energy systems. Other potential applications include using synbio to detect and remove environmental contaminants, monitor and respond to disease and develop new drugs and vaccines.

While these and other applications may not be widely available for years, synthetic biology is already in use for creating food additives that will start to show up in products on arocery shelves later this year. Switzerland-based Evolva is using synthetic biology techniques to produce alternatives to resveratrol, stevia. saffron and vanilla. The company's "synthetic vanillin" is slated to go into many foods as a cheaper and limitless version of real vanilla flavor. But many health advocates are outraged that such a product will be available to consumers without more research into potential dangers and without any warnings or communities around the world. "Synbio vanilla...could displace the demand for the natural vanilla market," reports FoE. "Without the natural vanilla market adding economic value to the rainforest in these regions, these last standing rainforests will not be pro-tected from competing agricultural markets such as soy, palm oil and sugar." Critics of synbio also worry that releasing synthetic life into the environment, whether done intentionally or accidentally, could have adverse effects on our ecosystems.

Despite these risks, could the rewards of embracing synthetic biology be great? Could it help us deal with some of the tough issues of climate change, pollution and world hunger? Given that the genie is already out of the bottle, perhaps only time will tell.

labeling to let consumers know they are eating organisms designed and brought to life in a lab.

"This is the first major use of a synbio ingredient in food, and dozens of other flavors and food additives are in the pipeline, so synbio vanilla could set a dangerous precedent for synthetic genetically engineered ingredients to sneak into our food supply and be labeled as 'natural,'" reports Friends of the Earth (FoE), a leading environmental group. "Synthetic biology vanillin poses several human health, environmental and economic concerns for consumers, food companies and other stakeholders."

For example, FoE worries that synbio vanilla (and eventually other synthetic biology additives) could exacerbate rainforest destruction while harming sustainable farmers and poor

Dear EarthTalk: I know that some of us are genetically predisposed to get cancer, but what are some ways we can avoid known environmental triggers for it?

Cancer remains the scourge of the American health care system, given that four out of every 10 of us will be diagnosed with one form or another during out lifetime. Some of us are genetically predisposed toward certain types of cancers, but there is much we

can do to avoid exposure to carcinogens in our environment.

According to the Environmental Working

The American Cancer Society reports that smoking and poor nutrition each account for about one-third of the 575,000 U.S. cancer deaths each year.

But smoking and obesity are obvious and other cancer triggers aren't so easily pinpointed. In 2010 the President's Cancer Panel reported that environmental toxins play a significant and underrecognized role in many cancers, causing "grievous harm" to untold numbers of Americans. And EWG reports that U.S. children are born "pre-polluted" with up to 200 carcinogenic substances already in their bloodstreams.

Given this shocking fact, it may seem futile to try to reduce our bodies' chemical burden, but it could be a matter of life and death. EWG lists several ways anyone can cut their cancer risk. First up is to filter our tap water, which can include arsenic, chromium and harmful chemicals. Simple carbon filters or pitchers can reduce contaminants, while more costly reverse osmosis filters can filter out arsenic or

The foods we choose also play a role in whether or not we get cancer. Eating lots of fruits and vegetables is healthy, but not if they are laden with pesticides. Going organic when possible is the best way to reduce pesticide exposure. And when organic foods aren't available, stick with produce least likely to contain pesticides (check out EWG's "Clean 15" list of conventional crops containing little if any pesticide residue). EWG also suggests cutting down on high-fat meats and dairy products: "Long-lasting cancer-causing pollutants like dioxins and PCBs accumulate in the food chain and concentrate in animal fat."

Eliminating stain- and grease-proofing chemicals (Teflon, Scotchgard, etc.) is another way to cut cancer risks. "To avoid them," says EWG, "skip greasy packaged foods and say no to optional stain treatments in the home." And steer clear of BPA, a synthetic estrogen found in some plastic water bottles, canned infant formula and canned foods "To avoid it eat fewer canned foods, breast feed your baby or use powdered formula, and choose water bottles free of BPA," reports EWG. Personal care products and cosmetics can also contain carcinogens. EWG's "Skin Deep" cosmetics database flags particularly worrisome products and green-lights others that are healthy.

Another cancer prevention tip is to seal wooden outdoor decks and playsetsthose made before 2005 likely contain "pressure-treated" carcinogenic arsenic in order to stave off insect infestations. Of course, avoiding too much sun exposure-and wearing high-SPF sunscreen—when using those decks and playsets is another important way to hedge one's bets against cancer. Dear EarthTalk: What would you say are the most important steps we need to take as a nation to counter the impacts of climate change?

-- Ned Parkinson, Chino, CA

Americans care more about the environment than ever before and the overwhelming majority acknowledges that climate change is real and human-induced. But still we continue to consume many more resources per capita than any other nation and refuse to take strong policy action to stave off global warming-even though we have the power to do so.

Reducing greenhouse gas emissions can be achieved in a top down manner-via legislation mandating reductions in fossil fuel emissions—or in a bottom-up fashion with individuals and businesses doing their part by driving and flying less, conserving more and embracing greener forms of energy. Environmental leaders would like to see Americans take both paths to cut greenhouse gas emissions as fast as possible.

The Natural Resources Defense Council (NRDC), a leading green group, has proposed a five-step plan for Americans follow to cut greenhouse gas emissions by 80 percent by mid-century. Step One is to cut global warming pollution via "strong legislation that caps carbon emissions and makes polluters pay for the global warming gases they produce." Step Two involves investing more in green jobs and clean energy. Producing more fuel efficient cars constitutes Step Three. Creating green homes and buildings is Step Four. Step Five: Build more sustainable communities and transportation networks.

Individuals need to play a role, too, by altering our behaviors to reduce our individual carbon footprints. NRDC has several suggestions along these lines as well. Walking, biking or using public transit instead of driving is one. If you must drive, make sure for best gas mileage that your car is tuned and your tires are properly inflated. If in need of a new car, look into a hybrid or electric that consumes less or no

On the home front, weatherization can go a long way to lower heating and air conditioning needs, thus saving significant amounts of energy. Also, upgrading old appliances to more energy efficient models and switching out old lightbulbs with new compact fluorescents (CFL) or LEDs will keep carbon footprints down. If your utility has a green energy option-with power from wind, solar or other renewables choose it, even if it costs more than the coal-based electricity. And for things you can't change there are carbon offsets you can buy that support renewable energy projects that will offset your carbon emissions.

But perhaps the most important tool we have as individuals for battling global warming is our voice. "Send a message to your elected officials, letting them know that you will hold them accountable for what they do-or fail to do-about global warming," instructs NRDC. On the group's website you can customize a letter to President Obama urging him to finalize a carbon pollution standard for new power plants, and direct the Environmental Protection Agency to set tough new standards for existing plants.

Environmentalists are optimistic that President Obama will take strong action to fight global warming during his second term. But even if he convinces Congress to pass binding legislation limiting carbon outputs, each of us will continue to play an important role through how we lead our own day-to-day lives.

TIPS ON FIREWORKS PHOTOGRAPHY

Capturing fireworks displays is very common to those who have SLR camera with basic controls such as shutter speed and aperture. But there are more to these than the controlling the light intake. Gears and vantage point play a lot too.

I love to take photos of the Annual Fireworks competition at La Ronde St. Helene Island of Montreal because each country participating shows different amazing style. Canada Day is one of those events that you don't need to go far. Most of the cities have their own event and end up with firework display. Here are the basic things to consider:

1. Use a Tripod

Perhaps the most important tip is to secure your digital camera to something that will ensure it doesn't move during the taking of your shots. This is especially important in simply photographing fireworks because you'll be using longer shutter speeds which will not only capture the movement of the fireworks but any movement of the camera itself

2. Remote Release

One way to ensure your camera is completely still during fireworks shots is to invest in a remote release device. These will vary from camera to camera but most have some sort of accessory made for them. The other way of taking shots without touching your camera is to use the self timer.

3. Framing Your Shot

One of the most difficult parts

of photographing fireworks is working out where to aim your camera. The challenge you'll face in doing this is that you generally need to aim your camera before the fireworks that you'll be photographing goes off - anticipation is key. Here are a few points on getting your framing right.

Scope out the location early

Planning is important with fireworks

and getting to the location early in order to get a good, unobstructed position is important. Think about what is in the foreground and background of your shots and make sure you won't have people's heads bobbing up into your shots (also consider what impact you'll have on others around you also). Take note of where fireworks are being set up and what parts of the sky they are likely to be shot into - you might also want to try to ask some of those setting up the display for a little nformation on what they are planning. Also consider what focal lengths you might want to use and choose ppropriate lenses at this time (rather than in the middle of the

· Watch your Horizons - One thing that you should always consider when lining up fireworks shots is whether your camera is even or straight in it's framing. This is especially important if you're going to shooting with a wide focal length and will get other background elements in your shots (ie a cityscape). Keeping horizons straight is something we

covered previously on this site and is important in fireworks shots also. As you get your camera on your tripod make sure it's

level right from the time you set up.

• Vertical or Horizontal? - There are two main ways of framing shots in all types of photography, vertically (portrait) or horizontally (landscape). Both can work in fireworks photography but I personally find a vertical perspective is better particularly as there is a lot of vertical motion in

fireworks. Horizontal shots can work if you're going for more of a landscape shot with a wider focal length of if you're wanting to capture multiple bursts of fireworks in the one shot – but I don't tend to go there that often.

- Remember your framing I find that when I photograph fireworks that I spend less time looking in my viewfinder and more looking at the sky directly. As a result it's important to remember what framing you have and to watch that segment of the sky. Doing this will also help you to anticipate the right time for a shot as you'll see the light trails of unexploded rockets shooting into the sky.
- 4. Focal Length?One of the hardest parts of photographing fireworks is having your camera trained on the right part of the sky at the right time. This is especially difficult if you're shooting with a longer focal length and are trying to take more tightly cropped shots. I generally shoot at a wider focal length than a tight one but during a show will try a few tighter shots (I usually use a zoom lens to give me this option) to see if I can get lucky with them. Of course zoomed in shots like

the one to the left can be quite effective also. They enable you to really fill the frame with great color. Keep in mind however that cropping of your

wider angle fireworks shots can always be done later to get a similar impact in your photography.

5. Aperture

auestion common around photographing fireworks displays is what aperture to use. Many people

you need a fast lens to get them but in reality it's quite the opposite as the light that the fireworks emit is guite bright. I find that apertures in the mid to small range tend to work reasonably well and would usually shoot somewhere between f/8 to f/16.

6. Shutter Speed

Probably more important to get right than aperture is shutter speed. Fireworks move and as a result the best photographs of them capture this movement meaning you need a nice long exposure. The technique that I developed when I first hotographed fireworks was to shoot in 'bulb' mode. This is a mode that allows you to keep the shutter open for as long as you hold down the shutter (preferably using a remote shutter release of some type). Using this technique you hit the shutter as the firework is about to explode and hold it down until it's finished exploding (generally a few seconds). You can also experiment with set shutter speeds to see what impact it will have but I find that unless you're holding the shutter open for very long exposures that the bulb technique works pretty well. Don't keep your



Canada Cautions Russia on Proposed Crimea Legislation

March 11. 2014 - Foreign Affairs Minister John Baird today issued the following statement:

"Canada, alongside our G-7 partners, is gravely concerned by news that Russia may be proceeding with draft legislation aimed at the absorption of Ukraine's Crimea region into the Russian Federation. Russia appears to be preparing the ground for outright, illegal annexation of Crimea.

"Russia's invasion of Ukraine is a clear violation of Ukraine's sovereignty and territorial integrity and of international law. As Prime Minister Stephen Harper indicated last week, Canada and our partners will not recognize the legitimacy of a referendum-planned for March 16-held in a region under illegal military occupation, nor will we consider as valid any corresponding legislative motion in Moscow designed to legitimize it.

"If Russia's legislators move forward with the annexation bill currently being considered by the Duma, they will only contribute to their country's growing isolation.

"We remain extremely concerned

about the ongoing crisis and continue to call on Russia to respect Ukraine's sovereignty and territorial integrity, including its 1994 Budapest Memorandum obligations."

Bustos, who is currently based in Manila and under contract with GMA 7, told the Inquirer that he "screamed for a good 10 minutes" when he received an e-mail inquiry from producers of the "Today" show, aired on NBC.

Bustos' a cappella rendition of Aloe Blacc's song was shown twice, on Friday and Saturday, in the "Today" segment dubbed "Webstatic," which spotlights videos that are trending in the Net.

He described the exposure on mainstream US television as "wonderful."

It's just starting to sink in, he said, "[but] now that I have an even bigger audience, I am thinking of new ideas." ■

The goal of the said campaign is to donate sturdier bangka to fishermen in areas hit by Yolanda.

Marian said that replacing the damaged boats of these fishermen will give them and their family a chance to start life anew and sustain a living.

Exactly a month after the campaign launch, it was able to fulfill its commitment to give away 100 boats as part of its first wave. "Nawala lahat ng pagod ko nang makita ko 'yung 100 families na binigyan namin ng bangka. Nakakataba ng puso na nangyari 'yung pinangarap naming mangyari," she confessed.

The said project also aims to help these fishermen sustain their living by checking up on them after a certain period of time. "Siguro within five months, ano ba ang nangyari sa mga taong binigyan naming — nakasurvive ba sila, naka-ipon ba sila, nakatulong ba itong bangkang ito? Hindi lang siya basta project lang, kumbaga nakatali kami sa buhay nila," explained Marian.

Dingdong, for his part, has been very active in his own advocacies. In 2009, Dingdong formed his own foundation, Yes! Pinoy Foundation, which has helped thousands of students in public schools and more recently, families in areas affected by recent calamities including Yolanda. The foundation has been involved in various social development programs advocating for education, youth development and disaster response,

among others.

shutter open too long. The temptation is to think that because it's dark that you can leave it open as long as you like. The problem with this is that fireworks are bright and it doesn't take too much to over expose them, especially if your shutter is open for multiple bursts in the one area of the sky. By all means experiment with multiple burst shots - but most people end up finding that the simpler one burst shots can be best.

7. ISO

Shooting at a low ISO is preferable to ensure the cleanest shots possible. Stick to ISO 100 and you should be fine.

8. Switch off your Flash

Shooting with a flash will have no impact upon your shots except to trick your camera into thinking it needs a short exposure time. Keep in mind that your camera's flash will only have a reach of a few meters and in the case of fireworks even if they were this close a flash wouldn't really have anything to light except for some smoke which would distract from the real action (the flashing lights). Switch your flash

9. Shoot in Manual Mode I find I get the best results when shooting in manual exposure and manual focus modes. Auto focusing in low light can be very difficult for many cameras and you'll end up missing a lot of shots. Once your focusing is set you'll find you don't really need to change it during the fireworks display - especially if you're using a small aperture which increases depth of field. Keep in mind that changing focal lengths will mean you need to need to adjust your focusing on most lenses.

10. Experiment and Track Results

Throughout the fireworks display periodically check your results. I enerally will take a few shots at the start and do a quick check to see that they are OK before shooting any more. Don't check after every shot once you've got things set up OK (or you'll miss the action) but do monitor yours shots occasionally to

ensure you're not taking a completely bad batch. Also experiment with taking shots that include a wider perspective, silhouettes and people around you watching the display. Having your camera pointed at the sky can get you some wonderful shots but sometimes if you look for different perspectives you can get a few shots that are a little less cliche and just as spectacular.

Hope you find these techniques helpful and useful in taking good shots. Remember practice makes perfect shots.

Hollywood celebrities talk about Manny

Liam Neeson and Mark Wahlberg may be among the biggest names in Hollywood action movies, but when it comes to "real action stars" both celebrities admit to being fans of Filipino Boxing Champion Manny Pacquiao.

Neeson who narrates the documentary Manny says he has been a fan of Pacquiao "for many, many years."

"What a boxer. He is one of the greats," the Irish actor said during his most recent guesting at ABC's Jimmy Kimmel Live!

Kimmel and Neeson then chatted about co-starring together in Manny, which will be having its world premiere during the week-long South by Southwest Film Festival in Austin, Texas on March 8.

"After I narrated (our) film, the

producer sent me an e-mail with a little film footage of Manny saying to the camera, 'Hello, Liam, I look forward to meeting you,' and I'm showing it to everybody," Neeson shared with the TV host. "I haven't met him... but he is a fantastic boxer."

Pacquiao himself has appeared on the Kimmel show several times, and Kimmel shared that he was also interviewed for the documentary.

Another very vocal Pacquiao fan is Mark Wahlberg, who often visited the eight-division champion at the Wild Card Gym in Los Angeles whenever Pacquiao trained there.

Wahlberg even credited Pacquiao as his model when he portrayed retired boxer Mickey "Irish" Ward in the movie, The Fighter.

"Every time he was training at Wild Card Gym, I watched him because my whole approach was, I wanted to look like a Manny Pacquiao-caliber fighter. I didn't want to look like another actor who's doing an okay job," he was quoted in one of his interviews.

Other personalities appearing in the documentary include actor Jeremy Piven; boxers Oscar de la Hoya and Evander Holyfield, singer Dan Hill, respected sportswriters and boxing analysts as well as friends and family of Pacquiao.

Directed by Ryan Moore and Leon Gast, Manny takes a look at the inspiring life story of Pacquiao who rose from poverty to become a 10-time boxing world champion, congressman and international icon.

Gast won an Oscar for Best Documentary Feature (1996) for When We Were Kings a film about the classic match between Muhammad Ali and George Foreman which happened in Kinshaha, Congo, in 1974.



The film also features original music by composer Lorne Balfe (Inception, The Dark Knight, Iron Man, Sherlock Holmes) and songs by Yardnoise with Chad Hugo (The Neptunes/NERD).

Manny opens on March 12 in Philippine theaters and will be distributed by Solar Entertainment Corp. ■
