DRUMMONDVILLE - The first bill of the new Parti Québécois government will attack corrupt practices revealed at the Charbonneau Commission, probing the construction industry and the impact of corruption on political parties in the province.

Ministers entering a special two-day PQ caucus meeting in Drummondville offered reporters hints of what the government plans to do National Assembly when the reconvenes next week for the first time with Pauline Marois as premier. But while its initial focus will be fighting corruption, the PQ government also intends to stick to its agenda of pushing for Quebec independence, adopting a new, tougher Bill 101 to protect the French language, while pursuing measures to preserve Quebec's French, secular identity.

As well, Finance Minister Nicolas Marceau promised a vote before the Christmas adjournment on his plan to modify the \$200-a-head health tax for the 2013 tax year.

Marceau told reporters that while the Sept. 4 election returned a minority PQ government, none of the three opposition parties represented in the assembly won a majority either, appealing to them to work with the PQ on this issue.

"I have taken that into account," Marceau said. "They should too."

Corruption - will it ever be eradicated?

It is common knowledge that corruption has become a way of life in many parts of the world, especially where there is a lot of poverty. In a developed country like Canada, it seems quite a surprise that it also exists, considering that most bureaucrats are highly paid.

Many articles have been written about corruption, and the degree of gravity of its effects on the economic, social and political life of a country. The current inquiry into the corruption in the construction industry and its connection to organized crime makes us wonder when and for how long have these secret dealings been going on. According to the news, the practice of giving kickbacks has been a part of doing business with the government for decades. Indeed, times have not changed as corruption still remains in our midst. Tracing back to the corruption time machine, we have read about a commission of inquiry called by then Quebec Premier Robert Bourassa for he could no longer ignore a "deep-rooted culture of violence and intimidation in Quebec's This construction industry.' commission, headed by Robert Cliché, a judge with strong New Democrat Party lineage was joined by Brian Mulroney, a Conservative Party organizer at the time and Guy Chevrette, a vice-president of the Centrale de l'enseignment du Quebec. The commission's lawyer was Lucien Bouchard. They held 68 days of hearings and focused on 279 characters in the union and construction world. When the Cliché commission filed their 602-page report in May 1975, the inquiry had "morphed from a probe into the exercise of union freedoms into an exposé of what was then described as 'an organized system of corruption without parallel in North America.' An excerpt from this article shows that corruption always has a way of reaching the top of the ladder.

Union leaders were discredited and cabinet ministers implicated. The trail of misconduct led to Bourassa's office, where the premier's special adviser had reportedly asked a union boss to help with a by-election on the same day he offered a monopoly over work at James Bay. The inquiry concluded that union corruption could not have been so deeply entrenched unless it had been actively supported by the government."

For a period of four years, it was reported that the Bourassa government "worked hand in glove with gangster union leadership in the province's construction industry." Some of the commission's recommendations were enacted but there were still obstacles to a genuine permanent overhaul in the construction industry.

Evidently, we are witnessing the same problem of corruption in the construction industry. As we hear and read about the testimonies of witnesses being questioned by the Charbonneau Commission, we wonder where it will lead us. Will these be given much weight in the future election of our representatives? Will the people learn how to hold our public officials accountable?

Corruption is defined in the sense to include bribery, wider extortion, fraud, deception, collusion, cartels, abuse of power, embezzlement, trading in influence and money laundering. From all the reports we have read about, all of these illicit activities appear to be going on. The allegations are so serious that many people could hardly wait to see the end of this. The report will only be submitted by next year but the consequences of the allegations are definitely going to cause some political upheavals at City Hall.

It is still too early to make up our minds about who is guilty and who is not. We are left with conjectures of responsibility. As the Ottawa Citizen editorial concludes, "if the damning evidence bears out, all Montreal politicians, even the clean ones, will have to explain how they remained conveniently ignorant."

Can corruption be eradicated? It appears that it is next to impossible to do so. However, this does not mean that we should give up the fight for it is like a disease which must be cured. If hold our elected officials we accountable for their actions. somehow, we can put a dent on corruption practices that hurt everyone.

MONTREAL, October 25, 2012 -On the occasion of an Education Series on the Holocaust and the celebration of the 100th birthday anniversary of Mr. Raoul Wallenberg, the mayor of Montréal, M. Gérald Tremblay, received at City Hall the members of the Centre commémoratif de l'Holocauste à Montréal as well as the survivors of the Holocauste in order to nominate posthumously M. Raoul Wallenberg, to the title of Citoyen d'honneur de la ville de Montréal." During the Second World War, M. Wallenberg saved thousands of Jews from their certain death.

"Many Hungarian Jews saved by M. Wallenberg became immigrants and citizens of Canada. They are today Montrealers who are active in all spheres of activities. With their children and their grandchildren, they contribute to the economic, cultural and social development of the city. In their name and in the name of those who were killed, we must celebrate those people, like Raoul Wallenberg who rose against the infamy," declared Mr. Tremblay.

"We are very proud that the City of Montreal underscored in such a fashion the importance of acting in favor of human rights. Here, in Montreal, the moral responsibility of intervention concerns all citizens," declared Mr. Larry Nachshen, President of the Centre commémoratif de l'Holocauste à Montréal.

In 1985, Wallenberg was bestowed the first posthumous title of "Citoyen d'honneur du Canada." A monument is dedicated to him in the garden of the Anglican Cathedrale in downtown Montreal - a hommage of Montrealers to this remarkable man who saved so many Jews. The monument was created by the sculptor Paul Lancz, a Hungarian Holocaust survivor.

"The Jewish community and the

Montreal administration joined together in the common values of accepting and including the importance of human rights and human dignity. We work together in common agreement to promote human rights and testify that our responsibilities are there. Our Charter of Human Rights and Responsibilities is proof of our commitment." added Mr. Tremblay.

The City of Montreal, by means of the different programs in support of cultural diversity and reinforcement of exchanges between citizens in Montreal, focuses on the development of a society more just, peaceful and inclusive. The support and compassion that animate Montralers, their tolerance and their open minds are in perfect correlation with the work of Mr. Wallenberg.

More than 100 000 members, of the Montreal Jewish community, are considered the most important and oldest in North America. They contribute to the economic development of Montreal and to its cultural and gastronomique deployment.

Tagalog prevalent in Canada

Tagalog is the second mostspoken language in Canada, according to the latest census of tatistics Canada.

The agency says the Filipino community is growing faster in Canada than any other foreign community as a result of the Filipinos' robust immigration to Ottawa.

The Filipinos permanently or temporarily living in Canada number 667,674, followed by Australia with 345,592 and Japan with 290,358.

In 2011 Canada admitted more permanent residents from the Philippines than from any other country at 34,991.

Experts say the increase, up from just 11,011 in 2002, is largely due to the Live-In Caregiver Program, which provides nannies to Canadian

CBA urges government not to pass Bill C-377

OTTAWA – October 25, 2012The Canadian Bar Association (CBA) has serious reservations about Bill C-377, Income Tax Act amendments (requirements for labour organizations) and is urging the government not to pass the legislation.

"The Bill contains a significant number of privacy concerns and lacks the appropriate balance between legitimate public goals and respect for privacy interests protected by law," says the CBA in its letter to the Commons Standing Committee on Finance.

Any legislation requiring public disclosure of salaries and other personal information of employees of independently governed organizations should be carefully considered, the letter adds. families, and also due to the nurses and service-sector workers who work to send money home.

Statistics Canada says the robust immigration into Canada explains why the number of Tagalog speakers rose 64 percent between 2006 and 2011.

In 2011 there were 279,000 people using Tagalog as their second language next to English, up from 170,000 five years earlier.

Statistics Canada says Tagalog is the most-spoken foreign language in Edmonton, the second most-spoken foreign language in Calgary, and the sixth-most-common language in Vancouver and Toronto.

Tagalog is also the second most-spoken language in Winnipeg, edging out French

The city was also marking the 100th anniversary of Wallenberg's birth, on Aug. 4, 1912.

While working as a Swedish special envoy in Hungary in late 1944, Wallenberg issued protective passports and sheltered Jews in buildings designated as Swedish territory.

He was captured by the Soviets in 1945, and was never heard from again.

The CBA notes that privacy is recognized as a fundamental constitutional right under Canadian law, and the Bill has the potential to invite a constitutional challenge and litigation.

"The Bill interferes with the internal administration and operations of a union, which the constitutionally protected freedom of association precludes, unless the government interference qualifies as a reasonable limitation upon associational rights. It is unclear from the Bill what the justification is for these infringements," says Arthur Grant, executive member of the CBA's National Constitutional and Human Rights Law Section.

Commenting on procedural points, the CBA says the Bill could have a serious impact on the operations of labour unions, yet these processes are embedded in amendments to the Income Tax Act. "In our view, it is inappropriate for

Jean-François Lisée, who seems to have assumed the role of government spokesman, told reporters the Marois government can attack corruption and deal with the other issues at the same time.

"Quebecers are a very able bunch who can walk, chew gum and text at the same time," he said.

And Lisée said the focus on corruption is consistent with the work of past PQ governments.

"When René Lévesque took power in 1976, (his) Bill 1 was to clean up political party financing," he recalled.

"Now we are back in power and first priority is cleaning up the construction, cleaning up political parties, cleaning up at the municipal level.

"It is part of our genetic code why, among other things, and Quebecers elect us, to clean up the inheritance we received from the Liberal party," he said.

Pay off the TOTAL balance at the end of every month. This isn't new advice, but it is solid advice.

Set up automatic payments so you NEVER miss a credit card payment again. Ramit gives specific examples in the book on how a single late payment on one credit card can instantly drop your credit score by a hundred points! Add in the late fees and added interest and you'll soon agree that you should avoid making credit card payments late for any reason. Ramit recommends setting up automatic payment through your checking account so that the entire balance is cleared on a set day every month.

Never pay just the minimum payment due. Even chipping in an extra \$20 a month will help drastically reduce the amount of interest you pay overall.

If you can't get a credit card because of your current credit history, try asking your local bank about getting a secured credit card, and moving up to a regular credit card with the same bank after a few months.

Even when you carry a zero

balance on your credit card, be sure to consumers to make purchases or cash regularly ask for a limit increase. The withdrawals through a payment more available credit your have with a zero balance, the better off your credit becomes.

Don't go hog wild. Open one new credit card account, then wait a year before opening another.

Avoid retail credit cards like the plague - even if they promise to save you 20% of the purchases lying on the counter, don't give in to the temptation. These cards often have awful terms and end up costing rather than saving you money.

The exception to these credit card "rules" is if you know you have little no control when it comes to spending. You know, those who will run up the balance and have trouble paying it off if they have a higher credit limit, or even own a credit card at all. But even then, you can always freeze your credit cards and still build your credit without using them.

If you know credit cards are dangerous for you financially, get rid of all cards and work on paying off what debt you have. Your best bet, in this case, may be to get a secured credit card from a bank that offers customers the option to turn off overdraft protection - meaning you can't spend any more than you have in the secured account and won't accrue any overdraft fees from over-spending.

network, such as American Express, MasterCard or Visa, with funds that have been paid in advance to a financial institution.

Currently there are fees associated with prepaid payment products that are not entirely clear to the consumer. The proposed Prepaid Payment Products Regulations would require that fees be disclosed to consumers in an information box displayed prominently on the product's exterior packaging, and that other information for the consumer to understand when using these products be provided prior to issuance in a manner that is clear, simple and not misleading.

"Improving consumer awareness through regulations like these helps to improve financial literacy and helps protect consumers. And a better-informed public means far more than better decision making; it can empower individual Canadians while contributing to a strong economy," added Deputy Commissioner Tedesco.

The proposed regulations would also limit certain business practices that could be harmful to consumers. For example, they would prohibit the funds from expiring and prohibit any maintenance fees for at least one year after a prepaid credit card has been activated for customer-

purchased products.

The proposed regulations will be available online in the Canada Gazette on October 26 for a 30-day comment period. Contact information for forwarding comments will be provided with the regulations.

The Minister also took the opportunity to announce the final publication of regulations prohibiting unsolicited credit card cheques on October 10, 2012. Credit card cheques are considered cash advances, which generally incur higher interest rates and fees, and do not offer an interestfree grace period.

"We welcome the Government of Canada's continuing efforts to protect consumers," said Laurie Campbell, CEO of Credit Canada Debt Solutions. "Regulations like these are essential safeguards for Canadians who need a little extra information when making important financial decisions."



Just because the environment is getting short shrift this election season due to our nation's lingering economic woes doesn't mean that candidates Obama and Romney can ignore the issue.

Environmentalists have cheered several of President Obama's

to label genetically modified foods so that consumers know what they are getting when they buy corn, sugar or breakfast cereal. Also, a 2011 Obama decision to deregulate the planting of genetically modified alfalfa and sugar beets incensed organic farmers and environmental leaders. Greens also worry about Obama's enthusiasm for an "all-of-the-above" energy policy that includes the practice of hydraulic fracturing ("fracking") to access natural gas in shale beds under wide swaths of the northeast and western U.S.

If re-elected, Obama would no doubt work to expand U.S. leadership on setting emissions limits in unison with other nations, and has pledged to continue to reduce our dependence on oil so as to lower greenhouse gas emissions. Conservationists are also hopeful that Obama will set aside threatened lands for protection from development as both Bill Clinton and George W. Bush did soon before leaving the White House.

Mitt Romney doesn't have much of an environmental track record, but has been open minded to both regulatory and market-based policy ideas.

moves during his first term, including: passage of the Recovery Act and its funding for environmental and habitat restoration and water quality improvements; passage of the first comprehensive National Policy for the Stewardship of the Ocean, the Coasts and the Great Lakes; and the signing of the Omnibus Public Lands Management Act of 2009, which expanded land protections and water conservation across two million acres of federal wilderness.

Obama also formed the Partnership Sustainable for Communities to bring together federal agencies to help communities nationwide improve access to affordable housing and increase low cost transportation options while protecting the environment. He also established new rules to reduce the negative impacts of mountain-top removal coal mining, set historic standards limiting greenhouse gas emissions from cars and trucks, made substantial investments in clean energy, proposed the first-ever carbon pollution limits for new fossil-fuel-fired power plants, and reduced carbon within the federal emissions aovernment.

On the downside, green leaders dismay Obama's lack of followthrough on a 2008 campaign promise

While Mitt Romney doesn't have much of an environmental track record from his days as Massachusetts' governor, he did get kudos for being open minded to both regulatory and marketbased policy ideas. He also supported a 2003 northeastern states agreement to reduce carbon emissions from power plants via a regional cap-andtrade emissions reduction plan. But in 2005 Romney abruptly pulled Massachusetts out of the plan, telling reporters that it didn't protect businesses and consumers from increased energy costs.

Romney is now pitching an energy plan that that embraces all the options, including fossil fuels, nuclear energy and renewables. But he recently told ScienceDebate.org that he opposes any kind of carbon tax or cap-and-trade system "that would handicap the American economy and drive manufacturing jobs away," adding that economic growth and technological innovation, "not economy-suppressing regulation," are key to protecting the environment in the long run.

nation's first "National Blueway." What is a National Blueway and does such a designation come with any funding for conservation or other purposes?

In May 2012 the Obama administration did indeed designate the Connecticut River and its 7.2 million-acre watershed as the first segment of a new National Blueways System, created to help conserve natural amenities and wildlife habitat and to preserve or enhance healthy recreational opportunities within significant river systems across the country.

The National Blueways program is part of the larger America's Great Outdoors Initiative created by the White House to establish a community-driven conservation and recreation agenda for the 21st century. Large blueways such as the Connecticut River watershed are extremely important not only as nurseries for biodiversity and filtration systems for fresh water supplies, but also as outdoor recreational outlets for millions of all-too-cooped-up Americans.

The Connecticut River watershed is a fitting first addition to the National Blueways program given its ecological, cultural and recreational importance to millions of Americans along its 410-mile run from the peaks of Vermont along the Canadian border through New Hampshire and Massachusetts to Connecticut, where it empties into the Atlantic Ocean. Some 2.4 million people across almost 400 communities live within the Connecticut River's watershed. The non-profit Trust for Public Land estimates that 1.4 million of those residents enjoy the watershed's natural beauty and wildlife and contribute upwards of \$1 billion dollars to local economies accordingly each year.

"The Connecticut River Watershed is a model for how communities can integrate their land and water stewardship efforts with an on 'source-to-sea' emphasis conservation," said watershed Secretary of the Interior Kenneth

federal designations for rivers (e.g., Wild and Scenic), which generally cover only a segment of a river and a narrow band of the riparian corridor." In contrast, a National Blueway includes the entire river from "source to sea" as well as the river's watershed.

National А Blueway designation doesn't establish any new protections for the watersheds in question, but it does open the door to some federal support for existing and/or new local and regional conservation, recreation and restoration projects. In the case of the Connecticut River, the new designation will help by improving coordination between local/regional planning entities and federal agencies such as the U.S. Army Corps of Engineers. The designation should also mean more funding for trail building and forest restoration projects.

It's unclear yet when other U.S. watersheds will be designated under the Blueways program, but there are certainly dozens if not hundreds across the country that could benefit from inclusion.

That Yellow Newspaper's Mytl vs. the COMELEC's Facts

After determining that there is sufficient grounds (prima facie) to hear the case filed on July 20, 2011 by Ms. Shinette Khoury of the Mabuhay Team against Mr. Cesar Manuel, Ms. Lina Flores and a few other members of the Samahang Makabayan, and after diligent and objective evaluation of all the pieces of evidence and testimonies presented by the opposing parties during the hearing of July 28, 2011, the COMELEC found the following defendants guilty or not guilty, as the case may be.

1. I will retract the complaint against Mr. Mel Domingo as I have verified that the statement was not heard coming from him but from Mr. Dick Dahiroc. I stand corrected, although since Mr. Dahiroc is a known supporter of the party, can he be cited for such foul remarks? It was heard by Ms. Hedy Azores and Ms. Nilda Archambault.

The ribald and chauvinistic remarks that Mr. Dick Dahiroc had said involving Ms. Au Osdon cannot be held against Mr. Cesar Manuel and other candidates of the Samahang Makabayan. We accept Mr. Manuel's argument that he did not and could not have any control of what any of his supporters had said or would say in public, particularly in his absence.

In any case, since Mr. Dahiroc had already apologized to Ms. Au Osdon and Ms. Osdon, in return, had already accepted his apology, the COMELEC considers the complaint closed and resolved. Therefore, no further action against either Mr. Dahiroc or Mr. Manuel by the COMELEC is necessary.

2. Mr. Bert Santos informed me that the following people told him that Samahang Makabayan offered to take care of their registrations. Jose Montes Augusto Alfaro Virgilio Cruz

Ortiz Santiago Benjamin Olalia

Jaime Rejuso There is no stipulation in the

FAMAS Election Rules, Regulations and Procedures that says taking care of one's registration [for FAMAS membership] is prohibited. Therefore, Mr. Cesar Manuel, the person who promised Messrs. Jose Montes, Augusto Alfaro, Virgilio Cruz, Ortiz Santiago, Benjamin Olalia and Jamie Rejuso, cannot be held accountable for offering to take care of those individuals' registrations. Assuming, for the sake of argument, that there was a presumption that Mr. Manuel might have paid or was willing to pay for those registrations, which is tantamount to vote-buying, he cannot and shall not be found guilty on mere presumption. The complainant failed to present even a shred of evidence beyond a reasonable doubt that Mr. Manuel or the Samahang

Makabayan actually did pay for such registrations.

Witness Augusto Alfaro merely pointed to Mr. Manuel as the person who promised to take care of the former's and a few other people's applications for membership. Mr. Alfaro did not say exactly that Mr. Manuel actually paid for their registrations. All Mr. Alfaro testified to was that Mr. Manuel said "Ako na ang bahala rito" (I'll take care of this) in reference to the application forms that were in the latter's possession. That statement is so ambiguous that the COMELEC could not do anything but give the accused the benefit of the doubt.

3. Pls. find attachment of travel itinerary of my client, Ms. Amelia Lelis who was in the Philippines since July 6 and did not give anyone authorization to register on her behalf.

The complainant failed to prove beyond reasonable doubt that it was indeed Mr. Cesar Manuel or the Samahang Makabayan who registered Ms. Amelia Lelis without her authorization. While Ms. Lelis' itinerary may prove that she was actually in the Philippines on the day of the allegedly bogus registration, it does not prove that Mr. Manuel or his party perpetrated the alleged violation.

4. Mr. Dante Tabamo waited in front of the FAMAS Center one afternoon as the volunteer failed to open on time at 1pm. Having been across the street, I immediately ran to serve him and his friend. Instead, they both commented that we should keep the Center more open as it is often closed.

Assuming that Mr. Dante Tabamo and his friend did in fact say what they were accused of saying regarding the Center being closed more often than it was open, the COMELEC believes that no one can be held accountable for holding an opinion whether such opinion is true or not. Besides, and more importantly, Mr. Tabamo did not make the statement in the course of a campaign.

5. Ms. Nora Dulla, a client of mine, will attest to the fact that Lina Flores handed to her a flyer of Samahang Makabayan's line-up, asking her to vote straight. This was during the Long Sault games, which I believe was on July 10, 2011.

On the strength of Ms. Nora Dulla's testimony, the COMELEC has found Ms. Lina Flores guilty for having violated Sections 10 and 11, Article VI of the FAMAS Election Rules, Regulations and Procedures. Ms. Flores distributed campaign materials on July 10, 2011, a date covered by the moratorium period and well outside of the campaign period.

Section 10 – Beginning June 22 at 9:00 A.M., the day the list of potential candidates will have been posted on

FAMAS Bulletin Board at FAMAS Community Center and on FAMAS website, and continuing through July 15, the day the official list of all candidates will have been posted on the FAMAS Bulletin Board at FAMAS Community Center and on FAMAS website, a moratorium on the distribution of campaign materials will be in effect. During the moratorium period, no streamers, banners, posters or palm cards may be hung up, distributed, moved, or used in any other fashion.

Section 11 – The campaign period will begin at 12:01 A.M. on July 16. No campaigning activities, as laid out in sections of Articles III and IV, may take place prior to this date. Candidates or supporters may not advance their candidacy or the candidacy of any other candidate or party in the election prior to the start of the campaigning period. All forms of campaigning as laid out in Sections III and IV are strictly prohibited during the moratorium period.

On Ms. Flores' contention that the complaint should not have been heard in the first place because Ms. Khoury failed to abide by the 48-hour rule on limitation as set forth in Section 1, Article X of the FAMAS Election Rules, Regulations and Procedures, the COMELEC believes that mere technicality must not be allowed to prevail upon common sense and, more importantly, upon what is just and right. It will be a travesty of justice if we let the accused to get off scot-free, and, worse yet, it may encourage, rather than discourage, the others in, or from, committing the same or similar violations.

COMELEC Member Andrea Neufeld says, "If we pass down the penalties as cautiously decided, A) we will show the community that we're serious about correcting violations and thus are setting a precedent as a COMELEC to show the community we're serious about helping bring about change. B) SMK will be mad, no doubt, but 48 hour rule or not, they VIOLATED THE RULES! And now they want to bide behind a technicality? To me that's

hide behind a technicality? To me that's an admission of guilt.

I think it is right to deal out a penalty to Lina Flores- SMK must be taught that this COMELEC doeks technicality will champion this COMELEC more than harm us - in the greater opinion of the community - as they will see a victory of integrity."

COMELEC Member Teresita Calica opines, "For me the time element is not a valid ground to dismiss the complaint. It is very clear that Lina Flores has violated one of the election rules and regulations. Such fraud destroys the sanctity of the ballot and takes away the trust of the voting public. We, the COMELEC, as guardian of democratic governance should discourage such actions and punish those who are found guilty by implementing the Election Rules and Regulations. It must also be stressed that our Mission is to conduct honest, fair, and peaceful elections but how can this be attained if the guilty is excused because of mere technicality? If this happens now then it will happen again in the future.

We have announced publicly during the hearing that we don't want to disqualify anybody. Therefore, I suggest that penalty be imposed on the candidates of the Samahang Makabayan Party." COMELEC Vice-Chair Ricardo Ribaya has this to say: "Ms. Lina Flores made a mockery of the moratorium period for campaigning. The severity of this violation cannot be taken lightly or be simply dismissed because of technicality and therefore deserves a penalty. Let us carry on with what we believe is right." Ms. Cynthia Puray stamped her

seal of approval on this decision as well. Said she, "It is very clear that there was violation as per COMELEC's Rules and Regulations."

Pastora Emma Denny and Mr. Santiago Valdez did not offer their opinions and considered to have abstained.

Under Section 1 of Article XXI – PENALTIES AND COMPLAINTS, Ms. Flores is penalized as follows:

One hundred fifty (150) votes will be deducted from the total number of votes she will garner in

the election of August 14, 2011. Furthermore, since the rest of her slate most likely benefitted from the illegal campaigning, the same amount of votes will also be deducted from the respective total votes of each one of her running mates from the presidential candidate to the last directorial candidate.

Section 1 – Contravening the election rules outlined above and those sections of the FAMAS Constitution and Bylaws relating to Qualifications of the Executive Board and the COMELEC may result in penalties or disqualification. The COMELEC reserves the right to issue multiple strikes or non-standard penalties where appropriate.

This part of our population significantly contributes to our nation building.As part of this year's celebration of the Month of Overseas Filipinos and International Migrants Day, the Inter-Agency Committee proposes to hold a photo competition in search of compelling photographs featuring the lives of overseas Filipinos. The National Commission for Culture and the Arts is designated the lead implementing agency for the said project. The photo competition shall also be complemented by an exhibition showcasing the entries received and the winning photographs. The project gives a venue for overseas Filipinos to share their artistic perspective on their daily struggles and triumphs through Photography.The competition is divided in two categories: Category A for ages 13-17 and Category B for 18 years old and above. Each category will have a 1st, 2nd and 3rd prize winners who will receive local travel opportunities to culturally rich tourist sites in the country. The exhibit will be held for the whole month of December 2012 as one of the activities in celebration of the Month of Overseas Filipinos.

Objective:

The project is aimed at raising the awareness of overseas Filipinos and the general Philippine publics on Philippine Diaspora through Photography.

Theme:

"A day in the life of an overseas Filipino: Stories of excellence, ingenuity, patience, hard work and success"

Term:

The Photo Essay Contest on the theme: "A day in the life of an overseas Filipino: Stories of excellence, ingenuity, patience, hard work and success" begins on August 15, 2012, and ends October 15, 2012. By an advertisement shall automatically submitting an entry, each contestant be disqualified. Photos that violate or agrees to the rules of the contest.

Who may enter:

The contest is open to all Filipinos based overseas, including migrant workers, immigrants, second and third generation Filipinos overseas, and

former Filipino citizens. It is divided into 2 categories: Category A: Aged 13-17 years and Category B: Aged 18 years and above. The entries must be from the migrants themselves and must present proof of being an overseas Filipinos, such as passport, Overseas Employment Certificate, seaman's book, stamp, alien registration certificate, naturalization papers, etc.

What to enter:

Each photograph must be original and taken at their workplace or place of residence which may be correlated to the theme. Entrants must provide for every entry, the following information on their entry forms: a keyword/entrv name of the photograph: place and date where the photo was taken; and a short caption in English language not to exceed four (4) sentences written by the photographer on his insights of the subject and its significance. The entry / entries must capture stories of overseas Filipinos that would raise awareness of how life as a migrant is all about, or must advocate for the protection of rights and promotion of welfare and interests of overseas Filipinos.

Photographs must have been shot by the entrant within the past three (3) years (since June 2009). Cropped photos are eligible. The judging panel will not accept slides, or computer-manipulated photos. Minor enhancements, including spotting, dodging, and burning, contrast and slight color adjustment or the digital equivalents, are acceptable. If the judges determine that a photographer has obviously altered his or her photo beyond what is allowed, they reserve the right to disgualify it.

High-quality scans (300 dpi at 8 x 10 inches) of non-digital photographs (original photo negative, print, or slide) are acceptable. Email submissions must not be larger than 6MB. It is advised that images are taken at the highest resolution possible (TIFF or JPEG), to ensure maximum optimization for print output.

For a photo in which a person is recognizable, entrants must secure a model release from the subject or, in the case of a minor, the subject's parent or guardian and provide it to the judging panel upon request. Download sample Release Form here.

Photographs that have been part or won any other competition, or offered elsewhere for publication or have been published in magazines and newspapers or have been produced as infringe upon another person's copyright are not eligible.

Employees and officials of the NCCA and member agencies of the IAC-MOF and their immediate relatives are not eligible to join the competition.

Common Errors in Taking Videos

Wouldn't it be great if you never made a mistake with your camcorder? If you were the perfect videographer, then you wouldn't need to read Filipino Star "Ask The Video" (heaven forbid!). The simple truth, however, is that you will make mistakes no matter how good a videographer you become. I have been filming since 1979 and until now I still commit mistakes. Some mistakes, however, are more common than others. With a little practice you can avoid those common mistakes and take your videos to a higher level.

First - Dont Waste Juice

Why is a "common" mistake so common? More than likely because it's an easy mistake to make. That said, let's start with one of the easiest and most annoying mistakes: the sin of wasting your battery power. You'd given the cutting-edge think, technology that gets packed into todays camcorders, a camcorder battery could easily provide reliable power for countless hours. The fact of the matter is the battery that came with your camcorder will most likely last for less than an hour of continuous use. That means it's important to conserve energy every chance you get, or you'll wind up with a battery that isn't ready for action when you are. Fortunately, conservation is easy. The most basic level of battery conservation is simply turning the camcorder off when you aren't using it. It may seem like common sense advice, but its easy to put the unit away with the power still on. Also, avoid over-using those camcorder features that consume extra juice. The power zoom, autofocus, fast forward/rewind controls and the flip-out LCD monitor are the most notorious of these. By limiting the amount of time spent using these functions, you can greatly increase the amount of shooting time on your battery.?

Forgetting to turn your camcorder off can lead to more mistakes than just a dead battery. ?Imagine that you've just spent several minutes shooting your kids at the communion at St.Kevin's. You confidently swing the camcorder strap over your shoulder as you head for the reception at Fu Lam. Mistake number one: you've forgotten to turn the power off.? And did you think to pause the camcorder? Uh-oh. Mistake number two. How many times have you gotten a roll of film developed only to find those few embarrassing photos when you accidentally took a picture that you didn't' intend to? The same thing can happen with your camcorder. If you don't remember to turn the power off when you are done using your camcorder, you might find yourself at home looking at fifteen minutes of excellent pavement footage, or even worse, a documentary about the inside of your camera bag.?The fact that the microphone continues to record audio as long as the tape is rolling can lead to even more embarrassing moments. If you forget to pause your camcorder, you might accidentally reveal on tape

the restaurant. These bloopers can really make you blush if you don't know they're there, and your audience isn't expecting them.

Read Your Viewfinder

The viewfinder isn't just for aiming the camcorder anymore. Your viewfinder provides ongoing status reports regarding your camcorder's activity. For example, you can easily tell whether or not you are recording just by looking in the viewfinder. Most units will display either a "PAUSE" or "RECORD" indication in one of the upper corners of the viewfinder, as appropriate. Most viewfinders also tell you the length of your focal setting, whether you are using manual or automatic settings, if you have applied a digital effect and alert you when you near the end of your tape. ?Most viewfinders will tell you when your battery is dying and estimate the time of death. My camcorder, for example, has a battery icon with a bar in it that gradually diminishes as I use up my battery's charge. This is the functional equivalent of a car's fuel gauge. When you see you're running low on juice, it might be best to plug in somewhere or replace the battery with a fresh one.

Moving Violations

Today's camcorders are so small and portable that it is easy to shoot footage while you're walking, running, driving, etc. This freedom of movement might tempt you to press the record button and carelessly whip your camcorder around from shot to shot, never thinking about what effect all that motion can have on your viewer. Let me sum up this kind of mistake in two words: motion sickness. Don't believe me? Why not see for yourself. Find a busy street downtown. Zoom in really tight and try to follow something as it moves. Do this for about five or ten minutes, then go home and watch your video. Before you've finished watching the reel, you will either have a splitting headache or will experience vertigo.. Frequent zooms and movements unnecessary are unsettling to the viewer. Your intentions may be good - to draw attention to something you feel is interesting - but the frequent-zoomand-follow technique actually gives your audience too little to look at for too short a time. The result is motion sickness. Keeping your shots as wide as is reasonable for as long as possible minimizes these jitters and produces better video. Avoid the urge to zoom while you record. Instead, pause while you change your shot, to reduce the amount of movement your audience has to endure.

Don't be a Jitter Bug Operator

You can avoid the jitters altogether by investing in a tripod to keep your shots rock-steady. Tripods offer additional benefits, as well. For example, they give you the opportunity to jump in front of the camera and become a part of the action. Some videographers make the mistake of getting lulled into a false sense of security when they prop their expensive video toys atop their tripods. Don't make the mistake of believing your camcorder is safe because it is on a tripod. Suffice it to say that tripods are only as sturdy as you make them. In many situations, they can and will fall, and all the kings horses... well, call it the "Humpty Dumpty Syndrome," you get the picture. As such, it behooves you to

attaching your camcorder to it. ?A tripods strength is in its legs. The legs of most tripods are telescoping, and must be locked down when they are extended. If they are not secured properly, the weight of even the most lightweight camcorder may be enough to cause structural collapse.?Video tripods often come equipped with a pan/tilt head. Typically, a knob controls the amount of tension applied to the head, limiting how easily the camcorder can be panned from side to side or tilted up and down. In actual use, you will probably keep the head loose so that you can follow the action around you. However, if you move away from your camcorder without securely locking the tripod head, there is a good chance that your camcorder will tilt helplessly skyward. Not only will you ruin the shot, the force of this tilting motion may be enough to upset your tripod and send your camcorder tumbling to the ground.?

Practice Makes Perfect

The important thing to remember, though, is that we all make mistakes, and the best we can do is practice to minimize the bulk of those mistakes. Remember to reduce battery use by turning off the power when you're not using your camcorder. Edit unnecessary pavement shots by remembering to press pause. Avoid the jitters by minimizing how many times you zoom in and out and by securing your camera to a tripod. If you do these things, you will find videography much more enjoyable. You wont become as frustrated in the shooting, and your audience will be happier in the watching.

The new images will also serve to keep the Canadian passport one of the world's most secure travel documents. The complexity of the images is - first and foremost - a security feature that makes the passport more difficult to counterfeit.

Our government IS tremendously proud of Canada's rich history. We urge all Canadians to learn more about the events and people that shaped Canada and the great sacrifices made to secure our freedom," added Baird.

Countries around the world review their passport designs and security features periodically to stay

"Canadians are generous and welcoming, but they have no tolerance for fraudsters who lie and cheat to jump the queue," said Minister Kenney. "This measure will help strengthen the integrity of our immigration system and prevent the victimization of innocent Canadians."

In addition to conditional permanent residence, CIC introduced, in March of this past year, a measure that prohibits sponsored spouses from sponsoring a new spouse for five years following the date they become a permanent resident. Along with a multilingual advertising campaign, CIC released a short video warning people not to be duped into committing marriage fraud. The video directs people to a specific page on the CIC w е b S i t е (www.immigration.gc.ca/antifraud) for advice on how to immigrate to Canada "the right way."

Grospe advocates the youth to fight for their rights

Nineteen-year old Renz Grospe, who came here from the Philippines five years ago, doesn't mind being called an activist. In fact, he is proud of the label. "One has to fight for his rights,

for his beliefs" said Grospe. "If he doesn't do it, who will do it for him?"

Grospe, who studies social science, major in Law and Society at Vanier College, aspires to be an his immigration lawyer to help kababayan (fellow countrymen). He the problems facing the knows immigrants, especially the caregivers. His mother , who runs an employment agency now, was under the Live-in--Caregiver Program when she immigrated here.

Together with the children of Pinay and a few youth, he formed the Anak Bayan Association to help his kababahyan. The association has eighteen members, ages 18 and over.Their goals are to make social changes in society.

In 2010, Grospe was troubled when he noticed that newly-arrived immigrants had not adapted yet to the ways of living in Canada. Many of them are factory workers. because they had no motivation to succeed in life. Although many of them finished high school or college in the Philippines, they found out that they still had to go back to school here after evaluation of their transcript of records. But instead of doing that, they are forced to work to survive.

Grospe, who serves as a committee organizer and education coordinator, explained that Anak Bayan holds workshops to help and motivate the newly-arrived youth. Workshops are held two hours a week or once a month. They are held at Immigrants Center in Van Horne. At the workshops, the youth introduce themselves and share stories the life they had in the Philippines and in Canada. Sometimes, they talk about their job experience here.

One of the issues being discussed at the workshops is about the rights of the workers.

"Most of them have no idea of the minimum pay in Canada," said Grospe. "They're shy to ask about it. They still have inferiority complex". Some of them don't even know what CSST is. They don't know what to do and where to go when they're injured at work. "

Ànother issue discussed at the workshops is labour dispute.

"There's a factory in Montreal where Filipino workers had to sign a document that they didn't know what they were signing for.," continued Grospe. "Actually, it's authorization to deduct union contributions from their pay."

Workshop about skill training is also held. "We're planning to have our own radio station. The kids will be taught how to conduct interviews."

A future plan is discussion and showing of Stranger Reunited. "It's a documentary film that depicts the lives of Filipino workers going abroad. They leave their children under the care of

their parents or relatives in the Philippines," said Grospe. "When they meet, say after 5 years, there's a generation gap. It seems there's a conflict. Parents treat their children as if they are still kids. When they meet, they seem to be strangers to each other .There's no bonding.

"Another problem is cultural shock. It takes time before the youth adapt here."

Anak Bayan holds fundraisings like garage sales. There was a time when the association made \$200.00. The money would be used in going to Toronto. The members of the association in Montreal will go to Toronto to know how Anak Bayan members there do workshops. Anak Bayan also has a chapter in Los Angeles and eventually, in Ottawa.

Grospe admits that organizing workshops is sometimes difficult.

"In the beginning, there were 18 members attending the workshop but the number dwindled down. Sometimes, the youth are tired with their work. What we do is combine business and pleasure. One time, we had camping where the youth got together and then discussed the issues. "

Grospe's immediate plan is to travel to Nicaragua this winter. He's one of the eight students at Vanier College chosen to travel to poor countries to study the peole and life there. Each student will live for twenty days in small communities.

"I chose Nicaragua because this country and the Philippines have similar culture," said Grospe. "I want to study the legal system there. The problem is that I've to shoulder the travelling expenses of about \$3,000. I've a part time job of two hours' a week. I can't work because I've 8 courses. I'm looking for corporate sponsors now."

There are 16 graduates but five were unable to attend due to a variety of reasons - work obligations, being out of town, and other personal reasons.

With the cooperation of all the teaching staff and students, the party was very successful. 
Most of Gilmore's graduates have immediately found jobs in nursing homes like Ethel Tugna, Mary Ann Gacutan, and Annabelle Alloso, who are currently working at Chateau Westmount. Giselle Arellano, a licensed nurse from improve themselves and recognize that education is important for their personal and professional growth. Moreover, she cited the importance of learning to speak French fluently for it is the key to finding a good job in Quebec.

There are other graduates from previous years who are able to land a job in the health care field because they took the PAB/PSW course. Gilmore College started the program in 2005 with Chinese nationals. One of them immediately landed a job at the Chinese General Hospital.

Gilmore's program has been upgraded from 400 to 600 hours in order to meet the needs of the current job market, in particular, government health care institutions. The teaching staff is well versed with the requirements of hospitals for they are all professional registered nurses and members of the Order of Nurses of Quebec. Even though they are retired from their nursing jobs, they have maintained their membership with the OIIQ (Ordre des Infirmiers et Infirmières du Québec) in order to supervise the students during their clinical practicum in a hospital or nursing home like St. Margaret CHSLD in Westmount where Gilmore College has been sending students since 2005.

A new group of PAB/PSW students will start classes soon on weekday evenings from 6 to 9, or 8 a.m. to 4 p.m. Saturdays and Sundays. Theory classes are given for a period of 10 months. After finishing the 6-month theory courses, students are required to do their practicum on Saturdays and Sundays from 7 a.m. to 3 p.m. during a period of 4 months.

Coconut milk is sold either as a canned product or frozen. It is now offered on sale at the Filipino Solidarity Cooperative (Marché Coop located on 5320-A Queen Mary Road. Please see the ad on page 3) It is on sale for one week starting October 31, to November 6, 2012.

Coconut milk is a common ingredient in many tropical cuisines, most notably that of Southeast Asia (especially Thai, Cambodian, Singaporean. Malaysian, and Sri Lankan), West African, West Indian, Filipino and Polynesian cuisines Coconut milk can usually be found in the Asian food sections of supermarkets either frozen or canned. Frozen coconut milk tends to stay fresh longer, which is important in dishes where the coconut flavor is not competing with currie


Ginataang Manolk (Chicken with coconut milk)

Ingredients

- 1 2 to 3 pound Chicken, cut into serving pieces
 - 1/4 cup white vinegar
 - 3 cloves garlic, crushed 1/2 cup water

 - 1/4 teaspoon pepper

How to make Fish Molee:

Wash the fish fillets thoroughly and then marinate with turmeric powder and salt. Keep it aside for 15 minutes.

Heat a little coconut oil in a frying pan and fry the fish fillets until golden brown in color.

Take the fillets out of the pan and pour some more oil in the pan. Heat it.

Add the mustard seeds. Allow to crackle.

In the same oil, fry onions, garlic and ginger till they get cooked. Add chopped green chilies, curry leaves and fry for a minute.

Now add the tomatoes and saute for a minute more. Do not mash the tomatoes.

Add the pepper powder, water, lemon juice, chili powder and salt to the above.

Cook at lower flame for 2 • minutes.

Add coconut milk and simmer the gravy for 3 to 4 minutes until it becomes thick.

Now add the fried fish fillets carefully to the above and cook for another 2-3 minutes or till the fish completely absorbs it.

Now put off the flame.

Fish Molee is ready. Serve it with boiled rice.



Fresh from appearing on the US talk show, "Ellen," Filipina YouTube singing sensation Zendee Rose "Random Girl" Tenerefe is keen on being part of boxing history under the team of her "Ninong," Manny Pacquiao.

The boxing champ has been

Anything you want to say to your kababayan who welcomed you with open arms and open hearts?

"Thank you, guys, so much for everything. You've been so good and you're making my whole journey memorable. I'm so happy to be here in Manila and I can't wait to come back and see all of you again. I wanna thank Jollibee for being so welcoming and making me part of the family."

Harvest Is Magical, But grueling

From the outside, winemaking seems romantic.

Farm workers lovingly tend to their vineyards throughout the spring and summer, and then hand harvest their grapes in the early fall. Those grapes are then gently crushed -- by foot, of course -- and turn into wine on their own through the magic of fermentation.

We're led to believe that winemakers simply monitor this process. They're there to make sure the final product winds up on the dinner table, but nature takes care of virtually everything.

This narrative is partially true. But it ignores the grueling, backbreaking work that goes into every bottle of wine we open.

Last week, I took part in that

work during a brief visit to California, where I visited 12 wineries in Napa Valley's Stags Leap District. I came equipped with rubber boots and gloves -- and offered to help wherever an extra hand was needed. I'm still hurting. Wherever wine is made, harvest

is a special time. But the work is exhausting.

In the evenings and early mornings, vineyards are packed with laborers collecting fruit, as picking while the weather is cool protects workers from daytime heat and ensures the grapes arrive in pristine condition.

The roads are equally busy. In the mornings and evenings, trucks are filled with grapes. Throughout the day, those same trucks haul equipment and vineyard supplies.

Wineries are abuzz with around-the-clock activity.

Forklifts and tractors are in constant use. As grapes come in, they're sorted, de-stemmed, and sorted again, as no winemaker wants leaves, spiders, or rocks to end up in her wine. With white wines, those grapes are crushed and pressed before fermentation. With reds, most of the grapes are typically left intact before they're placed in barrels or tanks. At this point, yeast gets to work -- gradually converting the sugar into alcohol and imparting a litany of new tastes and aromas. Over about two weeks, what begins as grape juice becomes wine.

Throughout this period, winemakers regularly taste the fermenting juice -- and bring samples to the laboratory -- to make sure the process is progressing as it should.

For every winemaking team, the cleaning never ends. From bins,

sorting tables, and de-stemming machines to tanks, pipes, and winemaking equipment, scalding hot water is used, over and over again, to hose down virtually everything. Wineries are very wet during harvest season.

The work seems endless. Harvest only lasts about six to ten weeks, depending on the grape variety. But during this period, 12- to 14-hour days are normal. Much of the work is messy and physical. Some is mindnumbingly repetitive. Many tough choices have to be made. And at every step, attention to detail is critical -- one small error could result in hundreds of gallons of lost wine.

Despite all the effort, harvest is magical. The air is filled with energy and the smell of fermenting grapes. Winemakers and their teams beam with joy, knowing their work will bring joy and pleasure to countless people. I can't wait to go back.

Former president Gloria Arroyo enters no plea in plunder case, seeks bail

A Philippine court entered a not guilty plea for former president Gloria Macapagal Arroyo on a plunder charge on Monday, a case that will be a litmus test of the government's ability to tackle entrenched corruption in the poor Southeast Asian nation.

Arroyo, 65, who ruled the Philippines from 2001 to 2010, sat silently beside her family and lawyer during the arraignment hearing while charges that she had misused state lottery funds from 2008 to 2010 were read to the court.

She could face a maximum sentence of life in prison if she is sent to trial and found guilty.

The court entered the not guilty plea on her behalf after she and her lawyer did not respond to the charge. Arroyo, wearing a pink shawl over a light pink dress and a neck brace, arrived in court in a wheelchair, smiling for photographers. She had two spinal operations two years ago.

"We do not recoanise the court's jurisdiction over this case," Raul Lambino, a lawyer and spokesman for the former president, told Reuters. Lambino, also a member of the lower house of Congress, said the case was "political persecution".

"She is sad over this case," he said, adding that Arroyo has a petition before the Supreme Court questioning the validity of the case

and the court's jurisdiction to hear it. Prosecutors accuse Arroyo and nine officials from the state lottery agency of misusing around 366

million pesos (\$8.88 million) in sweepstakes funds, accusing them of transferring the money to an intelligence fund for her use.

Arroyo also faces separate corruption charges for her alleged role in the misuse of public funds and kickbacks from a multi-million telecommunications deal with China's ZTE Corp. The public broadband deal was aborted in 2007. She is also on trial for electoral fraud.

She denies all the charges.

The plunder case is central to President Benigno Aquino's pledge to tackle endemic graft that

threatens to dampen rising business confidence on the Philippines.

Arroyo is currently under arrest at an army hospital. Her lawyer has also asked the court to grant her bail, as well as leave to visit the graves of her parents on November 1, when Filipinos traditionally pay respect to their ancestors.

Police whisked Arroyo back to the army hospital after the hearing. During the separate bail hearing, which she did not attend, her lawyer argued the evidence against the former president was weak.

Aquino is enjoying high ratings his approval after government's success in cracking down on corruption, including the impeachment of the Supreme Court chief justice. He says corruption pervades public life, keeping tax revenues low and hurting efforts to alleviate poverty.

A number of procedural steps follow Monday's hearing, with a pretrial hearing to start on February 14, 2013.

Dozens of Arrovo's supporters gathered outside the courtroom, chanting, singing and holding placards and banners. They were watched closely by about 400 police.

Pacquiao gives all in training



Pacquiao seeks reelection as Sarangani representative in next year's midterm elections

Manny Pacquiao's training assistant Buboy Fernandez has assured Top Rank founder and CEO Bob Arum that the eight division boxing champ and Sarangani representative remains focused in preparing for his fourth rematch with Juan Manuel Marquez in December.

This, it turned out, was in response to Arum's statement as told to boxing analyst and sports columnist Ronnie Nathanielsz in his post on Oct. 15 titled, "What is Pacquiao thinking?" that Pacquiao should "decide whether he is a boxer or he's a politician."

"I would like for the next two months for him to be a boxer and then the politics will take care of itself when he finishes the fight with Marquez. But

that's up to him," Arum was quoted to have said.

In an interview aired on "UKG," Wednesday, Fernandez said, "Wala daw ginagawa, puro daw pulitika ang nasa isip niya. Kung alam lang sana nila kung gaano kahirap 'yung ginagawa namin araw-araw, sa umaga...

"Pero 'wag naman nilang sobrahan kasi... Kung kaya na nila sumalo ng suntok dito, pumunta sila sa gym para malaman nila kung anong ginagawa araw-araw."

Fernandez also said in a separate interview aired on "TV Patrol" Tuesday evening, "Bawal ang istorbo [dito], saka napapakiusapan natin 'yung mga kaibigan natin. So maganda 'yung ano natin, ang ipinapakitang training.'

According to the "UKG" report, Pacquiao completes 18 mitt sessions and trains at least four hours each day at the Pacman's Gym in Gen San. Now on his third week of rigorous training, Team Pacquiao reportedly also discusses strategies and possible "dirty tactics" that Marquez may employ.

Meanwhile, Pacquiao's coach Freddie Roach isn't worried about the postponement.

Pacquiao and his entourage are set to leave for the US on Oct. 27.


